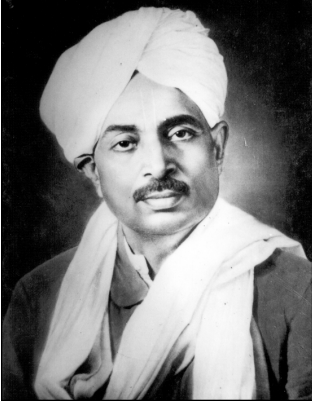


# सोनोपंत दांडेकर आमचे प्रेरणास्थान



सोनोपंत दांडेकर यांचा जन्म २० एप्रिल १८९६ रोजी पालघर तालुक्यातील केळवे-माहीम या गावी झाला. त्यांचे मूळ नाव 'शंकर वामन दांडेकर' आहे. वारकरी संप्रदायात त्यांची ओळख 'सोनूमामा' अशी आहे. त्यांचे प्राथमिक शिक्षण पालघर येथे झाल्यावर माध्यमिक शिक्षण नूतन मराठी विद्यालय, पुणे येथून तर उच्च शिक्षण पुण्यातील फर्ग्युसन महाविद्यालयातून झाले. तत्त्वज्ञान विषयात शिष्यवृत्तीसह त्यांनी एम.ए. ही पदवी मिळवली.

प्रसिद्ध तत्त्वज्ञानी गुरुदेव रानडे हे त्यांचे शैक्षणिक गुरु होते तर वारकरी संप्रदायाचे आत्मज्ञानी संत वै. पु. विष्णुपंत जोग ऊर्फ 'जोग महाराज' हे त्यांचे आध्यात्मिक गुरु होते. उच्चशिक्षित झाल्यावर इतर कोणत्याही क्षेत्रात कार्य करण्याची संधी आणि क्षमता असताना देखील त्यांनी

शिक्षण क्षेत्रात योगदान देण्याचा निर्णय घेतला. तत्त्वज्ञान विषयाचे अध्यापन त्यांनी केले. नूतन मराठी विद्यालयाचे मुख्याध्यापक, रामनारायण रुईया कॉलेजचे उपप्राचार्य व नंतर सर परशुराम महाविद्यालय, पुणे महाविद्यालयातून प्राचार्य म्हणून निवृत्त झाले. निवृत्ती समारंभात महाराष्ट्रातील जवळपास १२७ संस्थांनी त्यांचा सत्कार केला. यातून त्यांच्या लोकादराची प्रचिती येते. निवृत्तीनंतर महाराष्ट्रात गावोगावी कीर्तने, प्रवचने करून नीतीधर्माचा उपदेश केला. संत साहित्याचे संशोधित शुद्ध स्वरूप लोकांपुढे ठेवले.

वारकरी संप्रदायाला आधुनिक शिक्षण घेतलेल्या समाजात प्रतिष्ठा मिळवून दिली. सुशिक्षितांना संत साहित्याची गोडी लावली. विद्यादान, ज्ञानप्रसार व समाजसेवा हे ध्येय उराशी बाळगून ते अखेरपर्यंत कार्यरत होते.

पूजनीय जोग महाराजांनी आळंदी येथे १९१७ साली वारकरी शिक्षण संस्थेची स्थापना केली. ती संस्था नावारूपाला आणण्यात सोनोपंतांचा मोठा वाटा आहे. आज सुद्धा ही संस्था सुरळीत चालू असून त्यातील अनेक विद्यार्थी कीर्तनकार, प्रवचनकार म्हणून ख्यातकीर्त झाले आहेत. सोनोपंतांनी ज्ञानेश्वरीच्या ओव्यांचा जो अर्थ लावला आहे तो प्रमाण मानला जातो. पुणे विद्यापीठाची स्थापना करण्यात त्यांचा सिंहाचा वाटा आहे. नेवासा येथे ज्ञानेश्वर मंदिराची स्थापना त्यांनीच केली आहे. सार्थ ज्ञानेश्वरी, अध्यात्माची मूलतत्त्वे, ईश्वरवाद, ज्ञानदेव व प्लेटो, जोग महाराजांचे चरित्र, वारकरी संप्रदायाचा इतिहास हे त्यांचे लेखन कार्य आहे. अध्यापक, प्राचार्य, प्रवचनकार, कीर्तनकार, संत, विचारवंत, तत्त्वज्ञ, संपादक अशा अनेक भूमिकांतून समाजासाठी योगदान दिले.

सोनोपंतांच्या व्यक्तीमत्त्वाचे काही ठळक पैलू सांगता येतील. ते तत्त्वज्ञानी आहेत पण समाजविन्मुख नाहीत. स्वतःचा संसार नाही मात्र इतर अनेक संस्थांचे संसार चालवणारा. अध्यात्मात रंगलेला पण व्यावहारिक कर्तव्य चोख बजावणारा. ज्ञानी पण रुक्ष नाही. भक्त आहे पण अंधश्रद्धा नाही. व्यक्तिमत्त्वातून मीपणा लोपलेला आहे. म्हणूनच सोनोपंत दांडेकर महाराष्ट्रात 'आधुनिक संत' म्हणून ओळखले जातात.

महाराष्ट्राच्या या आधुनिक संतांचे दिनांक ९ जुलै १९६८ रोजी निधन झाले. आपल्या जन्म गावी उच्च शिक्षण देणारे उत्तम महाविद्यालय असावे अशी त्यांची इच्छा होती. त्यांच्या निधनानंतर पालघरमधील द्रष्ट्या लोकांनी शैक्षणिक संस्था सुरू केली. तिचे 'सोनोपंत दांडेकर शिक्षण मंडळी' असे नामकरण केले. आज त्यांच्याच प्रेरणेने हे संकुल शैक्षणिक क्षेत्रात जोमाने प्रगती करत आहे. महाविद्यालयात दरवर्षी ९ जुलै रोजी त्यांच्या पुण्यस्मरणानिमित्त महाराष्ट्रातील अभ्यासू व्याख्यात्याला बोलावून त्यानिमित्ताने त्यांच्या कार्याचा जागर आणि सद्विचारांची देवाणघेवाण होते. विद्यार्थ्यांना त्यांच्या बाह्यरूपाचा परिचय व्हावा, त्यांचे सत्कार्य सर्वांच्या समोर राहावे म्हणून महाविद्यालयाच्या प्रांगणात त्यांचे स्मारक उभे आहे.

**Eligibility:** A candidate for being eligible for admission to the three year integrated course leading to the degree of Bachelor of Science (B.Sc.) must have passed the Higher Secondary School Certificate examination (Std. XII) conducted by the Maharashtra State Board of Secondary and Higher Secondary Education, Pune or its equivalent in Science stream.

Admission will be on merit, based on order of preference as follows:

Aggregate marks at H.S.C. or equivalent.

Aggregate marks in Science Group (Physics, Chemistry and Biology)

Marks in Biology and Chemistry.

Marks in Biology

A candidate who has not offered Mathematics and Statistics as one of the Subject at H.S.C. (Std. XII) shall have to satisfactorily complete a course on Mathematics and Statistics (of 15 hours duration) during the academic year of First Year B.Sc. in which he is admitted.

XII) in Science stream conducted by the Maharashtra State Board of Secondary and Higher Secondary Education with Mathematics and Statistics as one of the subject or its equivalent. Admission will be on merit, based on order of preference as follows:

1. Aggregate Marks at H.S.C. or equivalent.
2. Aggregate Marks in Science Group (Physics, Chemistry and Mathematics)
3. Marks in Mathematics and Statistics and Physics. Marks in Mathematics and Statistics.

As per the guidelines of the University of Mumbai, New Education Policy 2020 will be implemented for the First Year Degree students from academic year 2023-24. There are chances of Subjects/Groups changes as per NEP of 2020 for first year courses.

## **Bachelor of Science (Information Technology) B.Sc. (I.T.)**

(Ordinance No. O.5051)

**Duration:** Three Years (Six Semesters)

**Circular No.:** No.UG./283 of 2007, Dated 16th June, 2007

**Eligibility:**

- (a) A candidate for being eligible for admission to the degree course of Bachelor of Science-Information Technology, shall have passed XII standard examination of the Maharashtra Board of Higher Secondary Education or it's equivalent with Mathematic and Statistics as one of the subject and should have secured not less than 45% marks in aggregate for open category and 40% marks in aggregate in case of Reserved category candidates.
- (b) Candidate who have passed Diploma (Three years after S.S.C. – Xth Std.) in Information Technology/ Computer Technology/ Computer Engineering/Computer Science/ Electrical, Electronics and Video Engineering and Allied Branches/Mechanical and Allied Branches/ Civil and Allied branches are eligible for direct admission to the Second Year of the B.Sc. (I.T.) degree course.However, the Diploma should be recognized by the Board of Technical Education or any other recognized Government Body. Minimum marks required 45% aggregate for open category candidates and 40% aggregate for reserved category candidates. **OR**

Candidates with post HSC-Diploma in Information Technology/Computer Technology/ Computer Engineering/ Computer Science/ and Allied branches will be eligible for direct admission to the Second Year of B.Sc. (I.T.). However, the Diploma should be recognized by the Board of Technical Education or any other recognized Government Body Minimum Marks required 45% aggregate for open category candidates and 40% aggregate for reserved category candidates.

## **Bachelor of Commerce (Management Studies) (B.M.S.)**

**Eligibility:** A candidate for being eligible for admission to the B.M.S. Degree Course shall have passed H.S.C. Examination of the Maharashtra Board of Higher Secondary Education or its equivalent examination or Diploma in any Engineering branches with two years or three years duration after S.S.C. conducted by the Board of Technical Education, Maharashtra State or its equivalent examination by securing minimum 45% marks for general category (in one attempt) at the respective Examination and minimum 40% marks for the reserved category (in one attempt). No college shall conduct any entrance test in any form and the admissions are purely based on merit duly following the reservation policy as per the norms of Government of Maharashtra. While drawing the merit list, weightage has to be given to students from Arts, Commerce and Science Stream at 12th standard level. The stream wise weightage to be given is as under :

The applications are to be accepted and processed by the colleges stream wise separately and the merit list is to be displayed stream wise taking into account the reservation policy prescribed by the Government of Maharashtra.

- The merit list is to be prepared and displayed stream wise.
- In case if no applications are received under the "Diploma in Engineering and other Category" or if the seats remain vacant in "Diploma in Engineering and other Category" after all the merit lists/forms are exhausted, the vacant seats must be transferred to Commerce Stream.
- In case if no application is received from any stream the vacant seats are to be distributed equally between the remaining two streams only.
- After the first merit list is displayed, if any seat allotted to one stream remains vacant, the same shall be distributed equally between the remaining two streams. In case of vacancy in one stream is of single/ odd number of seats, the single seat is to be allotted to the Commerce Stream. In case if no applications are available from the two streams, then all the vacant seats of such two streams must be transferred to the third stream.
- Step (d) be repeated for the subsequent merit lists till all the forms are exhausted or the final merit list is displayed, whichever is earlier.

### **ADDITIONAL FEES**

As per the guidelines related to Career Katta all the first year students will be admitted to Career Katta and the fees for Career Katta is Rs. 365 (for three years).

As per the decision by the CDC every student will complete a certificate course per year offered by the college for Rs. 100.

Students offering following subjects will have to pay following additional fees.

- 1) T.Y.B.Com. Direct & Indirect Taxation      Rs. 752
- 2) T.Y.B.Com. Computer System                      Rs. 1,950

In addition to above fees the students will have to pay other fees like Utility fee, Development fund, Library, Gymkhana, Examination fees, Caution money deposit etc. as prescribed by the University, Management or approved by the Shikshan Shulka Samiti.

### **MODE OF PAYMENT**

1. All fees including tuition fees for both the terms are required to be paid at the time of admission normally in the month of June except for the Backward Class students.
2. Backward Class students who are prima facie eligible for claiming G.O.I. Scholarship / Freeship and desirous to avail of these concessions, are not required to make the payment of fees at the time of admission. However, they are required to make the payment of minimum fees as prescribed by the competent authority.
3. The students except those mentioned at Sr. No. (2) intending to avail of any admissible fee concession should make the payment of fees for both the terms except tuition fees at the time of admission. They are advised to submit appropriate fee concession form within one month from the date of admission or latest before 31st July whichever is earlier. If the application for fee concession is sanctioned by the competent authority, the amount of fees will be refunded to the students only after its receipt from the competent authority. Notice in this respect will be displayed on the notice board on the receipt of the fees from the Govt. The students are requested to collect them immediately when the notice is displayed.
4. If the students including B.C. Students fail to submit appropriate fee concession / B.C. scholarship form in time or his claim for concession is rejected by the competent authority, he will loose the benefit of fee concession facility. Consequently, he will be required to make the full payment of College fees, if not paid earlier.

Blank forms for claiming fees concession of various types will be available in the college office on request.

## **4. REFUND OF THE FEES**

### **RULES FOR REFUND OF FEES**

The Rules (Ordinance 2859) relating to refund of fees after cancellation of admission as per the University of Mumbai Circular No. UG/412 of 2008 dated 11.09.2008 is given below:

Ordinance 2859 of University of Mumbai Refund of Tuition, Development and all other fees after cancellation of admissions:

The candidates who have taken admission in under graduate courses in Govt. colleges, in Govt. aided and unaided courses conducted by affiliated colleges, and recognised Institutions may request for refund of fees after applying in writing for cancellation of their admission to the course. The refund of fees as applicable shall be made on or before 30 day after the date of cancellation and thereafter. The percentage of fee for the course shall be refunded to the candidate after deducting charges as follows:

3.	From 21st day up to 50 days after commencement of the academic term of the course.	30% of the total amount of fees.
4.	From 51st day up to 80 days after the commencement of academic term of the course or 31st August whichever is earlier.	50% of the total amount of fees.
5.	From 1st September to 30th September.	60% of the total amount of fees.
6.	After 30th September.	100% of the total amount of fees.

**Note: The total amount considered for the refund of fees from the commencement of academic term of the courses includes the following:**

- (i) All the fee items chargeable for one year are as per relevant University circulars for different faculties (excluding the courses for which the total amount is fixed by other competent authorities).
- (ii) The fees charged towards group insurance and all fee components to be paid as University share (including Vice Chancellor fund, University fee for sports and cultural activities, E-charge, disaster management fund, examination fee and Enrolment fee) are non-refundable if payment is made by the college prior to the date of cancellation.
- (iii) Fee collected for Identity Card and Library Card, Admission form and prospectus, enrolment and any other course specific fees are NOT REFUNDABLE after the commencement of the academic term.
- (iv) All refundable deposits (Laboratory, Caution Money and Library etc.) shall be refunded at the time of cancellation.
- (v) Provided that wherever admissions are made through centralised admission process for professional and/or for any other courses by other competent authorities (as per the rules of relevant agencies) for the 1st year admissions. In case of admission to subsequent years of the course, 0.2859 is applicable for cancellation of admission.
- (vi) Provided further that this refund rule is concurrent with the rules and guidelines of other professional statutory bodies appointed for admission for relevant courses.

**• Important instructions for Reserve Category student:**

Eligible Reserve Category students who are admitted to the College on payment of concessional fees prescribed by the University of Mumbai are informed that, on cancellation of admission they will be required to pay additional amount depending on the period and percentage of deduction charges of the total fees prescribed for the course.

**NOTES RELATING TO FEE CONCESSION**

**ADMISSION GUIDELINES**

- A) The registration fees once paid for the PG course will not be refunded for any reason.
- B) The Tuition fee paid by the candidate for the course in which he/she is registered as a PG student will be refunded to him/her if he/she leaves the said course without attending any lectures, seminars or practical, subject to a deduction of 25% of the tuition fee. The application by the candidate for such refund will

only be entertained if it is received by the Principal/Registrar/Head of Department within fifteen days of the date of commencement of the lectures of the academic year in which the fees is paid

- C) The Tuition fee paid by the candidate for the course in which he/she is registered as a PG student will be refunded to him/her if he/she leaves the said course and joins another course of Mumbai University for which he/she applied at the same University admission is made later, subject to a deduction of 25% of the tuition fee.

## 5. GENERAL GUIDELINES / RULES FOR ADMISSION

Admission is purely on merit and is subject to availability of seats as per the directions issued by the University of Mumbai and Directorate of Higher Education, Mumbai region from time to time, duly following the reservation policy of the Government of Maharashtra. A transparent admission procedure is followed strictly based on the standard norms. Any modification in admission guidelines will be notified on the college notice board at the time of admission.

The prospectus along with an application form for admission to the first year of the Senior College will be made available from the date the H.S.C. results of the Maharashtra State Board are announced. They should be submitted to the college office as per the schedule displayed on the notice board. For admission to any class it is necessary to produce the original and the photocopy of each of the following documents:

1. A student seeking admission to the College shall have to submit an application in the prescribed form and present himself / herself for an interview with Principal / Admission Committee. No admission shall be regarded as duly granted unless it is confirmed by the college authority and / or the University.
2. Statement of marks of the previous examination.
3. No Objection Certificate from the Head of the Institution last attended with the enrolment/eligibility confirmation number (for students from other colleges who wish to join the S.Y. and T.Y. classes).
4. All Admissions are valid only for one academic year and are required to be renewed by application in the prescribed form for every subsequent academic year in the College.
5. Once an applying student is admitted to the College he shall be liable to pay the full fees for whole term subject to conditions printed hereunder.
6. **A student once admitted will be considered as duly enrolled for the academic year, unless he informs the Principal in writing of his intention to leave the College atleast one week before the commencement of the Term. If no such intimation is received, full fees for the Term will have to be paid. However, this is subject to rules and regulation in this respect printed hereunder.**
7. All Admissions are provisional until Eligibility Certificate and / or Transference certificate (wherever these are required for admission) are submitted to the College.
8. All students will have to abide by Mumbai University Ordinance 0.119 and 0.125 regarding regular attendance and satisfactory academic progress. Minimum 75% attendance for each term is necessary in order to be eligible for getting the terms granted.
9. All admissions of F.Y. Classes are valid subject to confirmation of enrollment / eligibility by the University of Mumbai.
10. Admission is granted on the basis of the application in prescribed form with the following credentials:
  1. Two attested copies of School Leaving Certificate. (For First Year Students)
  2. Statement of Marks of qualifying examination with two attested copies.
  3. H.S.C. Passing Certificate with two copies.
  4. Passport size 3 copies of the latest photograph of the student to be affixed on the application form, Identity Card, Library Reader Ticket.
  5. No Objection Certificate. (from last Attended College for S.Y. / T.Y. Students)
  6. Enrolment confirmation number and date for S.Y. / T.Y. Students.
  7. E.B.C. / P.T.C. / B.C. etc. concession sanction number, if any. (S.Y. / T.Y. Students)

8. Transfer Certificate is required to be produced within two months from the date of admission.
9. Admissions to the students coming from other University or Board of Secondary Education outside Maharashtra will be given only on producing provisional statement of eligibility from the University of Mumbai.
10. Enrolment to First Year Classes : Each & every student who have taken admission to First Year Classes have to submit ONLINE enrolment form to the University of Mumbai for confirmation of his / her admission to the course latest by 30th July, failing which his / her admission will stand cancel. This is a mandatory condition for admission to the First Year Class.

### **RULES OF ELIGIBILITY (For the students other than Maharashtra State Board)**

1. Students passing the Std. XII examination conducted by Board/University other than the Maharashtra State Board should submit a copy of the mark sheet and apply in the prescribed form for the Eligibility Certificate with the necessary documents and fees at the time of admission. After accepting the Eligibility Form, the College will apply to the University of Mumbai for the Provisional Statement of Eligibility Certificate. The Eligibility Section of the University of Mumbai will verify the documents and the Provisional Eligibility Certificate will be issued in a few days. If the student is not found eligible for the course, 50% of the amount of fees will be deducted and 50% will be returned to the student as per ordinance 0.111.
2. Passing Certificate: In case the Board/University does not issue the passing certificate, the student should obtain a letter from the concerned Board University stating that they do not issue a Passing Certificate.
3. Students should pay the necessary charges for getting the mark sheets verified by the Board/University from which they have passed the Std. XII examination.
4. For confirmation of eligibility, students should submit to the College Office the following original documents before the close of the First Semester.
  - i. Statement of marks of the previous examinations (Std. XII)
  - ii. The Passing Certificate
  - iii. Migration Certificate

### **PERCENTAGE OF RESERVATION OF SEATS FOR BACKWARD CLASS STUDENTS. (PALGHAR DISTRICT)**

As per the direction of the University of Mumbai and Govt. of Maharashtra regarding the policy of reservation of seats to the candidates belonging to Backward class is as under.

#### **Enrollment to First Year Classes**

Each & every student who have taken admission to First Year Classes have to submit ONLINE enrollment form to the University of Mumbai for confirmation of his / her admission to the course latest by 30th July, failing which his / her admission will stand cancel. This is a mandatory condition for admission to the First Year Class.

### **VERIFICATION OF CASTE CERTIFICATE**

Students belonging to Backward Class Category are instructed to get their caste certificates verified from the competent authority and obtain validity certificate. Otherwise they lose their claim of admission to B.Ed. and other courses on the basis of Caste Certificate. They should make an application in the prescribed form along with relevant papers to the Competent Authority latest by 15th November through this college. Prescribed forms are available in the college office.

### **ADMISSION GUIDELINES**

The Management or the college does not accept any donation or capitation fee for admission to any of the courses offered by the college. The public is cautioned not to fall prey to any misleading information regarding admission in the college against donation. In case, any person approaches the students/ parents for donation/ capitation fee, the same should be reported to the Principal immediately.

Application to each course and to each category has to be submitted in separate admission form.

## 6. CHOICE BASED CREDIT SYSTEM (CBCS) BY UGC

Under the CBCS system, the requirement for awarding a degree or diploma or certificate is prescribed in terms of number of credits to be earned by the learners. This framework is being implemented in several universities across States in India.

The main highlights of CBCS are as below:

- The CBCS provides flexibility in designing curriculum and assigning credits based on the course content and learning hours.
- The CBCS provides for a system wherein learners can take courses of their choice, learn at their own pace, undergo additional courses and acquire more than the required credits, and adopt an interdisciplinary approach to learning.
- CBCS also provides opportunity for vertical mobility to learners from a bachelor's degree programme to masters and research degree programmes. The detailed Guidelines for Choice Based Credit System can be learned from below URL [https://ugc.ac.in/pdfnews/8023719\\_Guidelines-for-CBCS.pdf](https://ugc.ac.in/pdfnews/8023719_Guidelines-for-CBCS.pdf) or Scan the Code at the end.

The terminologies used are:

1. **Academic Year:** Two consecutive (one odd + one even) semesters constitute one academic year.
2. **Choice Based Credit System (CBCS):** The CBCS provides choice for learners to select from the prescribed courses (core, elective or minor or soft skill courses).
3. **Course:** Usually referred to, as 'papers' is a component of a programme. All courses need not carry the same weight. The courses should define learning objectives and learning outcomes. A course may be designed to comprise lectures/ tutorials/laboratory work/ field work/ outreach activities/ project work/ vocational training/viva/ seminars/ term papers/assignments/ presentations/ self-study etc. or a combination of some of these.
4. **Credit Based Semester System (CBSS):** Under the CBSS, the requirement for awarding a degree or diploma or certificate is prescribed in terms of number of credits to be completed by the learners.
5. **Credit Point:** It is the product of grade point and number of credits for a course.
6. **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/field work per week.
7. **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student over all semesters. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters. It is expressed up to two decimal places.
8. **Grade Point:** It is a numerical weight allotted to each letter grade on a 10-point scale.
9. **Letter Grade:** It is an index of the performance of learners in a said course. Grades are denoted by letters O, A+, A, B+, B, C, D and F.
10. **Programme:** An educational programme leading to award of a Degree, diploma or certificate.
11. **Semester Grade Point Average (SGPA):** It is a measure of performance of work done in a semester. It is ratio of total credit points secured by a student in various courses registered in a semester and the total course credits taken during that semester. It shall be expressed up to two decimal places.
12. **Semester:** Each semester will consist of 15-18 weeks of academic work equivalent to 90 actual teaching days. The odd semester may be scheduled from July to December and even semester from January to June.
13. **Transcript or Grade Card or Certificate:** Based on the grades earned, a grade certificate shall be issued to all the registered learners after every semester. The grade certificate will display the course

details (code, title, number of credits, grade secured) along with SGPA of that semester and CGPA earned till that semester.

### **Allocation of Time as per Credits**

As per NCrF, the learner engaged time for 40 credits is 1200 hours.

- i. Theory Courses: A minimum of 15 hours of teaching per credit is required in a semester.
- ii. Laboratory Course: A minimum of 30 hours in laboratory activities per credit is required in a semester.
- iii. Internship: Credits for internship shall be one credit per one week of internship (or 30 hours of engagement), subject to a maximum of six credits per Semester. The internship shall be monitored jointly by the faculty and Industry/Organisation Mentor.
- iv. Field-based Learning/ Practices: These are the courses requiring learners to participate in field-based learning/projects generally under the supervision of faculty. A minimum of 30 hours of learning activities per credit in a semester is required.
- v. Community engagement and service: These are the courses requiring learners to participate in field-based learning/projects generally under the supervision of faculty. The curricular component of 'community engagement and service' will involve activities that would expose learners to the socio-economic issues in society so that the theoretical learnings can be supplemented by actual life experiences to generate solutions to real-life problems. 30 hours of contact time per credit in a semester along with 15 hours of activities such as preparation for community engagement and service, preparation of reports, etc., and independent reading and study. Thus, the total learner engaged time would be 180 hours for a 4-credit course.

### **Scheme of Evaluations**

Scheme of examination for UG/PG courses as per NEP 2020 <https://mu.ac.in/syllabus-of-nep-2020>

The performance of the learners shall be evaluated in two parts internal assessment with 40% marks by way of continuous evaluation and by semester end assessment with 60% marks by conducting the theory examination.

- I. Internal Assessment: It is defined as the assessment of the learners on the basis of continuous evaluation as envisaged in the credit based system.
- II. Semester End Assessment: It is defined as the assessment of the learners on the basis of performance in the semester end theory written examinations.

### **Modality of Assessment (FY, SY & TY Classes) (Subject to change as per guidelines of University of Mumbai with reference to NEP 2020)**

1. There will be a Semester end examination at the end of every semester.
  2. The examination will be conducted as per guideline given by Board of Studies of the respective subject and Board of Examinations and Evaluation, University of Mumbai.
  3. Semester End Assessment:  
The Semester End Examination for FY, SY and TY will be as per course credits and choice of examination typically for 2 credit course it will be of one hour duration while for 4 credit course it will be of 2 hours 30 minutes. In case of TY examination the same duration pattern will be followed **depending on the credits opted**. The question paper pattern will be as per syllabus copy duly approved by respective Board of Studies.
- \* In case of any discrepancy the guidelines issued by the University of Mumbai are final. All the guidelines regarding examination and evaluation are available on University of Mumbai website ([www.mu.ac.in](http://www.mu.ac.in)).

### **Standard of Passing**

- \* The learners shall have to obtain a minimum of 40 % marks in aggregate to qualify each course.

### **Method to carry forward the marks**

- A learners who PASSES in the Internal Assessment but FAILS in the Semester End Examination of the Course shall reappear for the Semester End Examination of that Course. However, his / her marks of the Internal

assessment shall be carried over and he/she shall be entitled for grade obtained by him / her on passing of the complete course.

- A learners who FAILS in the Internal Assessment but PASSES in the Semester End Examination of the course shall submit and reappear for the Internal Assessment in the form of projects for that course. However, his / her marks of the Semester End Examination shall be carried over and he / she shall be entitled for grade obtained by him / her on qualifying the course.

### **ORDINANCE REGARDING AWARD OF 10 GRACE MARKS TO STUDENTS FOR PARTICIPATION IN ANY ONE OF THE VARIOUS EXTRA CURRICULAR ACTIVITIES**

**0.229:** Candidates appearing for any of the University Examination/Examinations conducted by the Colleges on behalf of the University shall be eligible for the award of maximum 10 grace marks at their option, wherever necessary in addition to the marks secured in each Head of passing for participation in any one of the activities mentioned below:

- (i) Students who have enrolled as members of the N.C.C. and have satisfactorily completed the N.C.C. training programme during the academic year, as certified by the Principal/Commanding Officer of their respective College, OR
- (ii) Students who have participated in the N.S.S. programme and have satisfactorily completed at least 120 hours of Social Service comprising the time spent in at least two types of projects as certified by the Principal of their respective College and forwarded by the N.S.S. Programme Coordinator, OR
- (iii) Students who are one of the members of the team/s reaching the Quarter final stage at intercollegiate sports competitions or have secured one of the eight places in order of merit in individual sport event conducted by the University or have represented the University in sport events either at the Inter State or at Zonal level or at National level or at International level and have produced the necessary certificate from the Principal of their respective College and forwarded by Head of the concerned Section, OR
- (iv) Students who are members of team/s securing first three positions in cultural group events or have secured one of the first three places in individual cultural events or whose performance have been adjudged best as an Actor/Actress, Music Director, Lighting/ Sound effect operator, Author, Choreographer, or as Director in Group events conducted at the Intercollegiate cultural competition organized by the University, or have represented the University in any of the cultural events either at the State level or at the Zonal level or at the National level or at the International level in the same academic year as certified by the Principal of their respective college and forwarded by Head of the concerned Section, OR
- (v) Students who are members of the Students' councils constituted under Section 40 (2) (a) or Section 40 (2) (b) or under Section 40 (4) of the Maharashtra Public Universities Act 2016, and have actively participated in various schemes, programs and attended functions of the University during that academic year, as recommended by the Principal of the concerned College and certified by the Director of Students Welfare.

**229-A:** Students participating in the Extension Work activities organized by the Department of Lifelong Learning and Extension are entitled to the benefit of 10 grace marks on satisfactorily completion of 120 hours of work, except for Industry Orientation Project, where the minimum requirement is 240 hours of work, under various Extension Work Projects. The benefit of 10 grace marks to candidates would be available only in any one of the activities mentioned above, at their option subject to their fulfilling following conditions:

1. That they are appearing for any University Examination except the Examinations having point system of evaluation for the first time.
2. That in case of failure in one or more Heads of passing an Examination, the benefit of grace marks shall be granted to the extent of 5% of the maximum marks allotted to the Head of passing the concerned subject.
3. That the grace marks will be granted for the purpose of claiming exemptions in a subject/s, provided it shall not exceed 5% of the maximum marks allotted to a subject.

4. That the maximum of 10 grace marks shall be granted for the purpose of enabling a candidate for the award of class and or distinction in the Examination.
5. That maximum 10 grace marks will be added to the grand total, if the benefit of grace marks is not claimed in any of the above (2) to (4) conditions. In case of the grade pattern 0.1 is added to the SGPI.
6. That if the examination is conducted in semester and the marks of the two semesters are clubbed, the question of grant of 10 grace marks in odd semester under this Ordinance shall be considered at their option to students if they prove merit only in that particular odd semester in activities mentioned above and comply with all such conditions stipulated therefore, else the same shall be granted in even semester examination of that academic year.
7. That the grace marks under this Ordinance will not be counted for the award of scholarships, prizes and medals or any other awards.
8. That the rules relating to gracing under this Ordinance shall be applied first and the same shall separately be shown in the marks sheet of the candidates.
9. That the University authorities may consider withholding of any of the aforesaid benefit or to consider any of the merit/work of the candidates null and void if, in the option of duly constituted Disciplinary Committee, such an action is felt necessary, and communicated to University through the Principal/ Head of the Department.

## **7. UNIVERSITY AND COLLEGE EXAMINATIONS**

### NEP-2020 Examination and Evaluation Guidelines for UG Programs (Arts, Science, Commerce & Management) Semesters I to II

Circular No. DBOEE/Exam/ICC/2025-26/03      Date : 30th June, 2025

All Principals of Affiliated Colleges, Directors of Recognized Institutions, Heads of University Departments, Autonomous Colleges/Institutions, Director of the Centre for Distance & Open Education (CDOE), and Coordinators/Directors of University Sub-Campuses (Thane, Kalyan, Ratnagiri) in the faculties of Arts, Commerce, Science, and Management are hereby informed that the implementation of the National Education Policy (NEP-2020) guidelines for Examination and Evaluation shall be applicable to Undergraduate (UG) programs for Semesters I to IV from the Academic Year 2024-25.

As per the resolution of the Academic Council held on 20th May 2025, the University of Mumbai has adopted the following Examination and Evaluation Guidelines under the National Education Policy (NEP-2020), which shall be applicable to all Undergraduate Programs in Arts, Science, and Commerce & Management (Semesters I to II) from the Academic Year 2025–2026, as detailed below.

#### **I. EXAMINATION SCHEDULE AND TIMETABLE**

##### **1. Examination Dates:**

The University will announce the examination slots and the overall schedule for examinations and result declaration in due course.

##### **2. Timetable Preparation:**

Affiliated Colleges shall be responsible for preparing detailed timetables for both Regular and KT (Keep Term) examinations, strictly within the examination slots allocated by the University.

#### **II. EXAMINATION FORMS – REGULAR AND KT**

1. All students must fill out examination forms (Regular and KT) as per the schedule issued by the University.
2. The processes of subject selection, form filling, and form submission shall be managed by the respective colleges.
3. Seat numbers will be issued in the e-smart portal for regular and KT.

### **III. QUESTION PAPER SETTING AND EVALUATION**

#### **1. Question Paper Setting:**

Colleges are responsible for setting question papers for all Regular and KT examinations conducted under their jurisdiction.

#### **2. Evaluation and Moderation:**

Assessment of answer scripts, including moderation, shall be carried out at the college level.

#### **3. Interim Results:**

Interim results or marks for all assessments shall be declared by the respective colleges.

### **IV. REVALUATION AND MARKS SUBMISSION**

#### **1. Revaluation / Open House:**

Revaluation and/or Open House shall be conducted by colleges as per their internal academic policy and mechanisms.

#### **2. Marks Entry:**

Colleges shall prepare the final mark lists and enter them in the Samarth Portal as per the University schedule.

3. All data must be thoroughly verified for accuracy before final submission. No changes will be permitted after final submission.

### **V. RESULT DECLARATION AND MARKSHEET GENERATION**

#### **1. Application of Ordinances & Result Declaration:**

The University will apply the relevant ordinances and declare the final results for both Regular and KT examinations via the Samarth Portal.

#### **2. Marksheet Generation & DigiLocker Upload:**

Digital marksheets will be generated by the University and uploaded to DigiLocker as per the University's marksheet generation policy.

### **VI. GUIDELINES FOR DEFAULTING COLLEGES**

Colleges may be subjected to academic and administrative actions, including penalties, for any of the following defaults:

1. Failure to submit ERN (Eligibility Registration Number)
2. Failure to create or verify ABC ID
3. Incorrect subject selection
4. Improper or incomplete form filling
5. Non-generation of seat numbers
6. Failure to submit marks / Submission of incorrect marks

### **VII. GENERAL COMPLIANCE AND COMMUNICATION**

All affiliated colleges are required to:

1. Comply meticulously with all the above-mentioned procedures.
2. Ensure data integrity and adhere strictly to prescribed deadlines.
3. Maintain transparent communication with students and University officials.
4. Use the ticketing system in the Samarth Portal to raise any technical queries or concerns. The technical team shall address and resolve tickets accordingly.

Presently the Examination modalities of NEP 2020 are applicable to First Year, Second Year and Third year classes as per the guidelines of University of Mumbai.

#### **Third year Guidelines**

Learners studying in Third Year classes (Semester V & VI) and wish to appear for the University examination, have to submit ONLINE examination form to the University portal. Otherwise, learners will lose his/her

claim for appearing for University examination to be conducted by the University of Mumbai.

The degree will be awarded to learners who successfully complete 132 credits of the programme in period of 3 to 6 years from the year of enrolment to Semester I to Semester VI.

The scheme of examination will be divided into two components: Internal Assessment and External Assessment. The internal component will be program specific. It will consist of continuous evaluation including class-tests, assignments, seminars, projects, case studies, presentations etc. The external component means the semester end examination will be program specific depending upon the credit of the course. For 60 marks the duration will be 2 hours and for 30 marks the examination will be of 1 hour. For any specific guidelines regarding the internal and external examination the University of Mumbai guidelines regarding the examination and evaluation will be final.

For the practical examination the guidelines issued by the University of Mumbai will be taken into consideration.

**For FY, SY and TY the guidelines as per NEP 2020 will continue.**

Duration of the B.A., B.Com. and B.Sc. programmes will be of 3 years in the semester pattern and 4 years if the learners fulfils the eligibility criteria i.e. from Sem. I to Sem. VI and Sem I to VIII respectively for the learners enrolled in the academic year 2024-25 onwards.

The UG degree will be awarded to learners who successfully complete 132 credits of the programme i.e. Semester I to Semester VI and UG Honours degree to learners who successfully complete 176 credits of the programme i.e. Semester I to Semester VIII.

All Under Graduate Programs under NEP 2020 will be assessed through 60% Semester End Examination and 40% Internal Continuous Assessment as per the pattern approved by the Board of Studies, University of Mumbai. For details scan the QR Code on the last page.

A learner will be said to have passed the course if he/she passes both internal assessment and semester end examination.

The performance grading of the learners in FY, SY and TY shall be on the TEN POINT ranking system based on the aggregate performance of internal assessment and semester end examination as under:

The performance grading of the learners shall be on the **TEN POINT** ranking system based on the aggregate performance of internal assessment and semester end examination as under:

**ADDITIONAL EXAMINATION R.8439**

There will be one additional examination for Semesters I, II, III and IV for the learners who have remained absent in one or more courses. Learners who do not appear for both internal assessment and semester end examination are not eligible to appear for the additional semester end examination. Learners who are punished under 0.5050 (malpractices) and those who are detained under 0.119 (non-fulfillment of minimum attendance) are also not eligible to appear for the additional examination.

A learner who remain absent in some or all the courses on medical grounds or for representing the college/university in sports, cultural activities, activities of NSS, NCC/Sports training camps conducted by recognized bodies / competent authorities or for any other reason which is considered valid under exceptional circumstances and to the satisfaction of the Principal, will be exempted from the additional examination fees provided he/she furnishes all the necessary documents in this respect and he/she passes in all the courses for which he/she appears in the semester end examination.

### **Carry-forward of marks: R.8437**

A learner who passes in the internal assessment but fails in the semester end examination of a course shall reappear for the semester end examination of the course. However his/her marks of the internal examination shall be carried over and he/she shall be entitled for grade obtained by him/her on passing. Similarly a learner who passes in the semester end examination but fails in the internal assessment of a course shall reappear for the internal examination of the course. However his/her marks of the semester end examination shall be carried over and he/she shall be entitled for grade obtained by him/her on passing.

### **Examinations for repeater learners**

The learners who have failed in one or more courses of the semester end examination shall be allowed to appear for the examination in the next half, after submission of the examination form.

A.T.K.T. examinations for repeater students will be conducted in the first and the second half of the academic year for all semesters.

### **RULES WITH RESPECT OF A.T.K.T.**

**CARRYFORWARD OF MARKS IN CASE OF A LEARNER WHO FAILS IN THE INTERNAL ASSESSMENT AND/OR SEMESTER-END ASSESSMENT IN ONE OR MORE SUBJECTS:**

#### **R – 1**

1. A learner who PASSES in the Internal Examination but FAILS in the Semester End Examination of the course shall reappear for the Semester End Examination of that course. However, his/her marks on the Internal Examinations shall be carried over and he/she shall be entitled to the grade obtained by him/her on passing.
2. A learner who PASSES in the Semester End Examination but FAILS in the Internal Assessment of the course shall reappear for the Internal Examination of that course. However, his/her marks of the Semester End Examination shall be carried over and he/she shall be entitled for the grade obtained by him/her on passing.

#### **RULES FOR PROGRESSION (ALLOWED TO KEEP TERMS – ATKT)**

##### **R – 2**

##### **For UG programmes:**

1. A learner shall be allowed to keep term for Semester II irrespective of the number of courses of failure in Semester I.
2. A learner shall be allowed to keep term for Semester III if he/she earns 32 or more cumulative credits from Semester I & Semester II.
3. A learner shall be allowed to keep term for Semester IV irrespective of the number of courses of failure in Semester III.
4. A learner shall be allowed to keep term for Semester V if he/she earns 76 or more cumulative credits from Semester I, II, III & IV.
5. A learner shall be allowed to keep the term for Semester VI irrespective of the number of courses of failure in Semester V.
6. The result of Semester VI shall be withheld by the College till the learner passes all the Semesters from Semesters I to Semesters V.
7. A learner is allowed to take admission in semester VII (UG Hon./ PG Part I) only if he passed all courses of semesters I to VI (132 Credits).

##### **R – 3**

**For PG programmes: (This Rule is replaced by new rule as per University Circular No. AAMS\_UGS/ICC/2025-26/109, Date: 26th August, 2025)**

1. A learner shall be allowed to keep term for semester II irrespective of the number of courses of failure in Semester I.

2. A learner shall be allowed to keep term for Semester III if he/she earns 32 or more cumulative credits from Semester I & Semester II.
3. A learner shall be allowed to keep term for Semester IV irrespective of the number of courses of failure in Semester III.

All Principals of the Affiliated Colleges, Directors of the Recognized Institutions in all faculties are hereby informed that the recommendations made by the Academic Council at its meeting held on 15th July, 2025, vide Item No. 4.1 and subsequently approved by the Management Council at its meeting held on 22nd August, 2025 vide item No.14 for implementation of the ATKT Rules as under:-

"All the First Year Students will be promoted to Second Year irrespective of the number of credits for Progression in PG Programme prepared under NEP 2020 in the faculty of Humanities, Science, Commerce & Management and Interdisciplinary Studies from the Academic Year 2024-25."

### **GRACING**

At the time of compiling final result, the benefit of Gracing is given as per the New ordinances 5042, 5043, 5044 and 5045 as follows:

#### **0.5042: Grace marks for passing in each head of passing examination.**

The learners shall be given the benefit of Grace marks only for passing in each head of passing the examination as follows: upto 50 marks = 2, 51 to 100 = 3, 101 to 150 = 4

Provided that the benefit of such gracing marks given in different head of passing shall not exceed 1% of aggregate marks in that examination. This ordinance shall be applicable only if the candidate passes the entire examination.

**0.5043:** A candidate who passes in all the subjects and heads of passing in the examination without the benefit of either gracing or condonation rules and whose total number of marks fall short for securing Second Class / Higher Second Class or First Class by marks not more than 1% of the aggregate marks of that examination or upto 10 marks, whichever is less, shall be given the required marks to get the next higher class or grade as the case may be.

**0.5044:** A candidate who passes in all the subjects / heads of passing in the examination without benefit of either gracing or condonation rules and whose total number of marks in the subjects falls short by not more than three marks for getting distinction in the subject/s shall be given necessary grace marks up to three in maximum two subjects, subject to maximum 1% of the total marks of that Head of Passing whichever is more, in a given examination.

**0.5045:** If a candidate fails in only one head of passing, having passed in all other heads of passing, his/her deficiency of marks in such head of passing may be condoned by not more than 1% of the aggregate marks of the examination or 10% of the total number of marks of that head of passing in which he/she is failing, whichever is less. However condonation, whether in one head of passing or aggregate head of passing be restricted to maximum upto 10 marks only.

Only one ordinance i.e. 0.5042 or 0.5043 or 0.5044 or 0.5045 and not more than one ordinances, can be applied in the case of a candidate.

**0.229 A:** Students participating in NSS / NCC / Sports / Cultural Activities / Life Long Learning and extension activities and whose names are approved by the authorities are entitled to be graced maximum of 10 marks and not more than 5% in each head of passing.

Gracing under 0.5042/0.5043/0.5044/0.5045 and 0.229 A is applied simultaneously.

## **THE EXTRACT FROM THE AMENDED ORDINANCE NO. 5050**

The attention of the students is invited towards the amended ordinance No. 5050 relating to the conduct of examinations, nature of malpractice quantum of punishment, powers of the Principals of the college etc. The following extract relating to the F.Y./S.Y. B.A., B.Com., B.Sc. examination conducted by the college on behalf of the University of Mumbai is reproduced hereunder for the information of the students.

- a. "Unfair means" includes one or more of the following acts or omissions on the part of student/s during the examination period.
  - (i) Possessing unfair means materials and or copying therefrom.
  - (ii) Transcribing any unauthorised material or any other use thereof.
  - (iii) Intimidating or using obscene language or threatening or use of violence against invigilator or person on duty for the conduct of examination or man-handling him / her or leaving the examination hall without permission of the supervisor or causing disturbances in any manner in the examination proceedings.
  - (iv) Unauthorisedly communicating with other examinees or any one else inside or outside the examination hall.
  - (v) Mutual / Mass copying.
  - (vi) Smuggling-out, either blank or written, or smuggling-in of answerbooks as copying material.
  - (vii) Smuggling-in blank or written answerbook and signature of the Jr. Supervisor thereon.
  - (viii) Interfering with or counterfeiting of University/College/Institution seal, or answerbooks or office stationary used in the examination.
  - (ix) Insertion of currency notes in the answerbooks or attempting or bribe any of the persons connected with conduct of examinations.
  - (x) Impersonation at the University/College/Institution examination.
  - (xi) Revealing identity in any form in the answer written or in any other part of the answerbook by the student at the University or College or Institution examination.
  - (xii) Or any other similar act/s and / or omissions which may be considered as unfair means by the competent authority.
- b. "Unfair means relating to examination" means and includes directly or indirectly committing or attempting to commit or threatening to commit any act or coercion, undue influence or fraud or malpractice with a view to obtaining wrongful gain to him or to any other person or causing wrongful loss to other person/s.
- c. "Unfair means material" means and includes any material whatsoever, related to the subject of the examination, printed, typed, handwritten or otherwise on the person or on clothes, or body of the student (examinee) or on wood or other material, in any manner or in the form of chart, diagram, map or drawing or electronic aid etc. which is not allowed in the examination hall.
- d. "Possession of unfair means material by a student" means having any unauthorised material on his/her person or desk or chair or table or at any place within his/her reach, in the examination centre and its environs or premises at any time from the commencement of the examination till its conclusion.
- e. "Student found in possession" means a student, reported in writing, as having been found in possession of unfair means material by Jr. Supervisor, Sr. Supervisor, member of the vigilance Committee or Examination Squad or any other person authorised for this purpose, in this behalf, even if the unfair means material is not produced as evidence because of its being reported as swallowed or destroyed or snatched away or otherwise taken away or spoiled by the student or by any other person acting on his behalf to such an extent that it has become illegible. Provided report to that effect is submitted by the Sr. Supervisor or Chief Conductor or any other authorised person to the Controller of Examinations or Principal or Head or the Institution concerned or any officer authorised in this behalf. "Material related to the subject of examination" means and includes, if the material is produced as evidence, any material certified as related to the subject of the examination by a competent person and if the material is not produced as evidence or has become illegible for any of the reasons referred to in clause (e) above, the presumption shall be that the material did relate to the subject of the examination.

If no previous occasion a disciplinary action was taken against a student for malpractice use at examination and he/she is caught again for malpractices used at the examinations, in this event he/she shall be dealt with severely, enhanced punishment can be imposed on such students. This enhance punishment may extend to double the punishment provided for the offence, when committed at the second or subsequent examination.

**PRACTICAL/DISSERTATION/PROJECT REPORT EXAMINATION**

Student involved in malpractices at Practical/Dissertation/project Report examinations shall be dealt with as per the punishment provided for the theory examination.

18. The Competent Authority, in addition to the above mentioned punishments, may impose a fine not exceeding Rs. 300/- on the student declared guilty.

\*(NOTE: THE TERM “ANNULMENT OF PERFORMANCE IN FULL” INCLUDES PERFORMANCE OF THE STUDENT AT THE THEORY AS WELL AS ANNUAL PRACTICAL EXAMINATION, BUT DOES NOT INCLUDE PERFORMANCE AT TERM WORK, PROJECT WORK & DISSERTATION EXAMINATIONS UNLESS MALPRACTICE USED THERE AT).

**AN APPEAL**

An appeal against the finding of the Committee shall lie with the concerned competent authority, whose decision shall be final and binding. An Appeal made in writing within a period of 30 days from the date of imposition of the punishment, shall be considered by the competent authority on merit and shall be decided on the basis of the evidence available in the case and shall be heard in person in deserving cases, if the competent authority finds substance in the appeal. The competent authority shall supply typed copy of relevant extract of fact-finding report of the Inquiry Committee as well as documents relied upon (if not strictly confidential), pertaining to his/ her case to appellant/petitioner, if applied for in writing. Decision in the appeal shall be informed to the student concerned accordingly. The Court matters in respect of the unfair means cases should be dealt with by the respective competent authority.

## 8. COLLEGE RULES AND REGULATIONS

1. Every student on admission must have an Identity Card. This will be issued to the student on presenting an Identity Card size latest photograph. The students must always carry the Identity Card with his photograph affixed thereon duly attested and must present it for inspection whenever demanded by the authority. No student will be allowed in the college premises without Identity Card. Every student will have to affix one copy of his latest photograph of the usual size to his application for admission and give three copies to the Librarian for the Identity Card and Reader's Ticket.
2. Students must attend lectures, tutorials, practicals or unit tests according to the Timetable on all working days of the college. Absence at lectures/tutorials/practicals/unit tests and examinations without prior permission or leave granted by the Principal or the authority may lead to lose of term. Student has to complete to the satisfaction of the teacher/Principal the course study prescribed for the term. Students must note that if their attendance at lectures, tutorials or seminars is found unsatisfactory their terms will not be granted and they may not be allowed to appear for the Annual Examination. Resultantly they will lose the year.
3. In case of illness, students must apply for leave in writing as early as possible with a doctor's certificate attached to the applications and must report to the Principal immediately after resuming. Leave will be granted subject to rules & regulations in respect of the minimum attendance framed by the University.
4. Ragging is strictly prohibited.
5. A student is to attend his class to which he belongs only and should not attend other classes. Attending the class for which he is not enrolled will be an act of indiscipline and will be subject to punishment.
6. Conduct and behaviour of student in classes or in the premises of the college shall be such as will not cause any disturbance to fellow students or to other classes.
7. Students must not loiter in the college varandah while the classes are being engaged.
8. If a student has any difficulty or complaint regarding any college matters he is free to approach the Principal personally or in writing. He shall in no way approach or write to authorities other than the Principal and shall not write to the press anything without prior permission of the Principal.
9. No society or association shall be formed in the College and no meeting can be organised or addressed without the prior permission of the Principal.
10. No student shall collect any money or contribution for a picnic, trip, educational visit to any place, get-together, study notes, charity or any other activity without prior permission of the Principal.
11. Students should take proper care of the college property and help in keeping the premises neat, clean and tidy. Causing damage to the property of the College (i.e. disfiguring wall, doors, fitting or breaking furniture etc.) is liable for punishment.
12. Students applying for certificate, testimonials etc. requiring the Principal's signature on any kind of document or application should first contact the Registrar in office. No papers should be brought by students directly to the Principal for signature.
13. Students of the college must observe all Rules and Regulations of the College and undertake to submit to normal enforcement of the same to the satisfaction of the Principal. A student whose behaviour is found to be unworthy in any way is liable to be removed from the College. The Principal's decision in such matter shall be final.
14. Mobile Phone & Camera are strictly prohibited in the college.
15. Matters not covered by the existing rules will rest at the absolute discretion of the Principal.
16. Smoking / chewing tobacco is strictly prohibited.

## 9. ATTENDANCE

Minimum attendance required for being eligible to get the term granted & to appear for Annual Examination is minimum 75% of the working days of the College as per University Ordinance No. 0.119.

A days' attendance means attendance for all lectures, tutorial, practicals, seminar and any College programme of the day. For being eligible to get a term granted, a student besides 75% attendance must show satisfactory progress, good conduct, payment of all due fees and return of Library Books in time. For further details students are advised to contact Chairman of the Attendance Committee.

### **ORDINANCES 6086 RELATING TO THE ATTENDANCE FOR LEARNERS**

Ordinance: 6086: Attendance for learners:

- 1) There shall be the Attendance Committee, for smooth conduct of this ordinance, in every college/institute/Department of the University comprising of at least three members (to be nominated from other departments in case of the University Departments having less than 3 teachers), the Vice-Principal/Senior Teacher (Convener) and at least two more teachers ensuring representation of the concerned faculties, nominated by the Principal/Director/Head.
- 2) Every bonafide learner shall ordinarily be allowed to keep terms for the given semester in a program of his enrolment, only if he fulfills at least seventy five percent (75%) of the attendance taken as an average of the total number of lectures, practical's, tutorials etc. wherein short and/or long excursions/field visits/study tours organized by the college and supervised by the teachers as envisaged in the syllabus shall be credited to his attendance for the total no of periods which are otherwise delivered on the material day/s. Further it is mandatory for every learner to have min 50% attendance for each course & average attendance has to be 75%.
- 3) The same ratio shall be applied for computing the attendance of the learners by crediting the number of periods which are missed while participating in an extracurricular/co-curricular activity/competition/camp/ workshop/convention/symposium/seminar etc. where the said learner is officially representing the college/ University/ District/ State/ Country with the permission of the Principal /Director/ Head of the College/ Institute/ University Department or by the direction of the University Officer as the case may be wherein for the purpose of computing the average attendance the periods missed for what is envisaged here-in-above, at Sr. No 2, shall be deemed to have been attended by the said learner.
- 4) Without prejudice to what is stated here-in-above, the Principal/Director/Head of the concerned College/ Institute/Department of the University shall be the competent authority to condone the absentee of any learner further up to additional 25%, if deemed fit and on recommendation of the attendance committee of the said college/Institute/Department of the University, wherein it is mandatory on the said committee to do natural justice by giving personal hearing to every learner falling short of minimum attendance for keeping terms and recommending case by case to the competent authority having verified the genuineness and gravity of the problem that justifies the learner to remain absent, which generally shall be limited to his own sickness, sickness of his parent, death of his parent etc. supported by valid evidence, documentary or otherwise.
- 5) The attendance committee ensures that the attendance records are maintained in order and that the warning letters are issued to the defaulting learners at least twice in every semester & that in the first week of every month for the previous month default list it display on college notice board. If they are falling short of attendance while also displaying the list of defaulters declaring their respective attendance for the month. The defaulting learners should also be called (along with the parent/guardian wherever necessary) to meet the Convener, attendance committee in the middle of the semester with a view to make the consequences adequately clear while understanding the difficulties if any and encouraging the learner to comply with the requirement of the attendance. Needless to say that the learners should be made aware of the provisions of the ordinances for attendance at the time of admission and an undertaking may be obtained from them (countersigned by the parent/guardian wherever necessary) assuring regular attendance while understanding the consequences of defaulting.

- 6) At the end of the semester on recommendation of the attendance committee the Principal/Director/ Head of the college/Institute/University Department shall display list of the learners who are not allowed to keep terms, allowing them to appeal to the Principal/Director/Head of the College/ Institute/Department of the University within 3 days from the date of display of the notice. After disposing the appeals the Principal/Director/Head shall intimate the same to the In-charge of Examinations/the Controller of examinations to withdraw the examination forms of such defaulting learner sunder intimation to those learners ensuring that this communication reaches the concerned at least 10 clear days before the commencement of the respective examinations.
- 7) The learners whose terms are not granted by the college/institute/department of the University can appeal to the controller of examinations, if desired, in a prescribed form and by paying fees prescribed by the Management Council within 3 days from the receipt of this intimation and that the controller of examinations shall arrange a hearing of the learners along with their concerned Principals/Directors/Heads of the Department, represented in person or through a teacher nominated by them before the committee (one each for every faculty) nominated by the Management Council comprising of 3 members including the convener. The respective committees shall convey their decisions to the controller of examinations which shall be final and binding on the learners once accepted and communicated by the controller of examinations.  
(The existing Ordinances O.119, O.120 & O.125 are repealed)

## 10. FACILITIES AVAILABLE FOR THE STUDENTS

Since the college is situated 2 kms. away from the Railway & Bus station of Palghar, the College has provided with the help of ST authorities Bus service facility between Palghar station and College right from 7.00 a.m. in the morning upto 6.00 p.m. in the evening. The college also has provided cycle stand facility having capacity of 500 cycles & motorcycles stand for the benefit of local students.

### **HOSTEL FACILITY**

The students are hereby informed that Hostel facility is available for Boys and Girls Students belonging to Schedule Tribe Category. Students concerned may contact the warden of the Hostel for further details: Addresses: 1. **Government Boys Hostel**, BIDCO Road, Palghar. 2. **Government Girls Hostel**, BIDCO Road, Palghar.

### **BUS (State Transport) AND / OR RAILWAY CONCESSION FACILITY**

S.T. and / or Railway Concession facility is available to the students for their to and fro journey from their residence to college. Concession forms are available in the S.T. office. On submission form duly completed well in advance, the concession form will be endorsed by the college authorities.

Concession will be available on production of this concession form duly endorsed by the college to the respective authorities.

The student can get S.T. concession pass continued on production of earlier concession within stipulated period to the S.T. authorities. The students are not required to submit concession forms afresh for such continuation. If the S.T. / Rly. concession form / pass is lost, fresh application form will be recommended after collecting fine from the student, if the competent authority is satisfied for the reasons mentioned in the application and after fulfilling certain formalities. Railway concession facility for visit to native place during vacation is available to students as usual. Entry in admission form in respect of native place will be taken as the basis for this purpose. All these concession are subject to the rules and regulations framed by respective departments in this behalf.

### **MEDICAL FACILITY**

The college, having more than 8000 plus students from Junior & Senior wings, has provided adequate no. of medical aids boxes in College. For any type of Hospitalization, the college sends the students patients to nearby Hospital in the city for the purpose of proper treatment at his/her cost. Over and above these facilities, the college has provided the Group Insurance facility to the students in the College.

#### Gymkhana

The college also provides coaching and guidance of experienced teachers. No sports and extra-curricular activities can be undertaken by the students without permission of the principal.

The students participating in sports activities at the University / Inter Zonal Level are entitled to the benefit of 10 grace marks under 0.229 B. Please contact Incharge of sports activities of the college or office for further details in the matter.

### **Fitness and Yoga Centre**

The college has spacious modern Fitness and Yoga Centre. The college has appointed two technically sound physical trainers for the gymnasium. Our gymnasium has the facility of 1) Leg Curl, 2) Leg Extension, 3) Smith Machine, 4) Incline / Decline Bench, 5) Lat Pull Down, 6) Fly Machine / Peck Deck, 7) Shoulder Machine, 8) Incline Crunch (ABS) Machine, 9) Leg Press Machine, 10) Dumbbells up to 60 pds., 11) Olympic Rod - 45 pds, 12) Back Extension.

The college has a very big Yoga Hall also. Our Students are participating various "Best Physique Competition". Our College has a very large spacious Cricket and Football Ground, Volley Ball Court, T.T. and Badminton Hall with all the facility.

### **EXTENSION ACTIVITIES**

#### **1. NATIONAL CADET CORPS (N.C.C.) (Boys and Girls Unit)**

N.C.C. (Boys) Unit has been functioning from June 1971 and Girls Unit from June 2003 and form a characteristic feature of the college activities. Successful cadets of this unit are entitled to **an award of grace marks upto a maximum of 10 at the University / College Examination, under 0.229 A**. The college has provided sufficient infrastructural facilities for the NSS units and is planning to provide firing stimulator. Intake capacity of Boys Unit is 56 and Girls Unit is 52.

#### **2. NATIONAL SERVICE SCHEME - N.S.S. (Intake Capacity 300)**

The College is very keen right from very beginning in developing and expanding the activities of the NSS Unit of our college with a view to give social dimension to the present-day education, thereby making education more relevant to life. It functions as a complementary source of our Rural Development Centre, a distinguishing feature of our institution. The college has at present three NSS Units giving opportunity to nearly 300 students to participate in this NSS activities.

1. Admission to the NSS will be subject to number approved by the University.
2. The students enrolled as volunteers in the NSS will have to abide by the rules framed for the NSS e.g. rules regarding attendance, discipline, the work on Camps participation in Y.F.S.D. Camp etc.

The students who complete 120 hours of social work to the satisfaction of the authority, are given a certificate and are entitled to an award of grace marks upto a maximum of 10 at the University / College examination under 0.229 A.

#### **3. DEPARTMENT OF LIFE LONG LEARNING AND EXTENSION (DLLE)**

DLLE has been functioning from June 2010 in our college. The aim of DLLE is to promote a meaningful and sustained rapport between the University and the Community. The work of the students involved in DLLE have been considered for academic credit in addition to or as a part of their regular course of studies. The Extension work student should complete 120 hours of work for the benefit of 10 Grace Marks Under Ordinance 0.229A.

### **COLLEGE ANNUAL MAGAZINE**

Our College Annual Magazine offers an opportunity to the students for the expression of their potentialities in the various fields of literature such as Poetry, Essay, Fiction etc. It is multilingual. The students are expected to submit their creations to the section-in-charge for their processing as per notice displayed in this behalf. Late submission may lead to lose the chance of getting the place in magazine.

### **THE COLLEGE STUDENTS' COUNCIL**

The Students' Council is formed under the Maharashtra Public Universities Act 2016. The Principal is the

ex-officio Chairman of the Council, while the student members elect one of them as its Secretary The Students' Council helps the College administration in maintaining discipline and conducting various activities for the students.

The College Students' Council looks after the welfare of the students and to promote and coordinate the extra-curricular activities of different student's associations for better corporate life. The student ceases to be the member of the council when he ceases to be a student of the college.

### **VERIFICATION OF CASTE CERTIFICATE**

Students belonging to Backward Class Category are instructed to get their caste certificates verified from the competent authority and obtain validity certificate. Otherwise they lose their claim of admission to B.Ed. and other courses on the basis of Caste Certificate. They should make an application in the prescribed form along with relevant papers to the Competent Authority latest by 15th November through this college. Prescribed forms are available in the college office.

### **YCMOU CENTRE**

#### **YASHWANTRAO CHAVAN MAHARASHTRA OPEN UNIVERSITY**

The college has a centre of YCMOU, Nashik for last 20 years. The classes of B.A. and B.Com. degrees are conducted during Sundays and Holidays at the centre for counselling the students. The centre thereby gives an opportunity to the individual who want to prosecute their study in higher education, but could not take admission in the college as a day student. The admissions are open to any individual who is above 18 years and who qualify by entrance test conducted by the University or having HSC Certificate.

### **Preservation and protection of Rare Ayurvedic and Medicinal Herbals**

- 1) The college proposes to undertake ecologically and environmentally important project to save rare medicinal plants of this area as there is big threat to the survival of some medically important species. Conservation of such medicinal plants having great ecological value may help to create the job opportunities to coming generation. Therefore, the college sets up the medicinal and ayurvedic garden as a pilot project. Students from science faculty as well as interested in this programme can participate in this project.
- 2) The college also proposes to undertake training and propagation of medicinal farming among farmers with a view that the farmers from this area will take a crop of certain medicinal plants. It will be not only an addition to their economic level but such programme will facilitate to bring uncultivated land under cultivation as well as it will increase the employment opportunities to young generation.

## **STUDENTS WELFARE SCHEMES**

## **COMPETITIVE EXAMINATIONS**

The College promotes the activity of encouraging students to appear for competitive examinations like Graduate Excellence Examination thereby students intending to appear for such examination should see the Convenor, Centre of Excellance for further guidance.

## **BANK LOAN FACILITY**

The College has started under graduate and post graduate courses along with self financing courses. There is good response from the students of this area but it finds that the students taking admission to such courses find financial hardship in paying fees towards the courses. The college therefore has approached various banks in Palghar for Educational Loan to the students. The College will recommend needy students to the bank and students will get educational loan from the Bank and prosecute their studies calm and quietly. The needy students are instructed to avail this facility.

## **LIBRARY**

The College Library is well equipped with all essential Reference Books and Text-Books of all subject in Marathi, English, Gujrathi, Sanskrit and Hindi together worth over ten lakh rupees. The College Library subscribes to a number of standard journals, weeklies and dailies. A good amount has already been spent on books so far. Adequate recurring grants are also made available every year.

## **LIBRARY RULES**

1. In the beginning of every academic year a library ticket is issued to the student for borrowing books from the library. Only one book except reference books can be taken against this ticket for home reading for a period of one week. In case of late return of books students will have to pay fine of Re. 1/- per day.
2. A student can have Dictionaries, Back Volumes of Periodicals, Project reports and other reference books against his / her Identity Card for study in the library reading room. Such books can not be taken out of the library. The identity card will be forfeited and a fine of Rs. 50/- is levied if such book / books are taken outside the library is a must.
3. Maintaining peace, silence in to the library is a must.
4. Library facility is made available to the ex-students of this college appearing for any examination externally and to the general readers on payment of fees Rs. 250/- per annum and deposit for Rs. 500/-
5. Files, Bags, Personal textbooks are not allowed inside the library.
6. The borrower shall be responsible for any damage or loss done to the library documents borrowed by them shall be required to replace such material or to pay the double cost thereof.
7. Smoking and consuming chocolates etc. in to the library is strictly prohibited.

## **GENERAL INSTRUCTIONS**

All users are requested to strictly follow the regulations specified herewith:

- (a) Student's members have to show their Library I.D. while entering the Library and write their Name, Reg. No., Time and Sign the register kept at the entrance.
- (b) Students are supposed to enter the Library with clean dress.
- (c) Keep all the belongings at the entrance in pigeonhole and take only one note book of loose sheets.
- (d) Files, bags, personal text books are not allowed inside the Library.
- (e) No person shall write on, damage or disfigure book, journal or other materials belonging to the Library.
- (f) The borrower shall be responsible for any damage or loss done to the Library documents borrowed by them shall be required to replace such materials or to pay the double cost thereof.
- (g) Before leaving the Library, the reader shall leave on the table any books / periodical which he / she has taken for reference. The same shall not be kept back on the shelf by the reader to avoid misplacement. However, the book borrowed from the text book counter have to be returned to the counter.
- (h) Maintaining peace, silence in the Library is a must.
- (i) Loss of borrower card has to be reported immediately to the Librarian in writing.
- (j) Dictionaries, Back Volumes of periodicals, Project reports, and other reference to within the Library.
- (k) Library tickets are not transferable. Members are not allowed to sub-lend the books of the Library.
- (l) Mobile phones are strictly forbidden in examination hall. If a student taking an examination is found in possession of a mobile phone or any similar device, it will be confiscated by the college and will not be returned to the student until resolution is made by the unfair means enquiry committee about the matter.
- (m) Member should take care of their personal belonging. The Library is not responsible for any claim of loss of such articles found in the Library.
- (n) Smoking, consuming chocolates, etc., in the Library is strictly prohibited.
- (o) Any infringement of the norms and procedures will render the borrower the cancellation of library facilities.
- (p) In case of late return of books students will have to pay fine of Rs. 5 per day.
- (q) While charging the fine holidays will be counted.
- (r) Re-Issues of the books will depend upon the demand for the same.

(s) All cases of disregard of these Rules will be reported to the Principal for Appropriate action.

### COLLEGE BOOK SCHEME

The Book Bank facility is available for the backward class students' under special provision of students welfare division, Mumbai University of Mumbai. The library provides a set of textbooks to the backward class students with no charge for whole year, there are 4985 books under the scheme. The College also provides Book Bank facility to scholar and promising students.
