MEMORANDUM OF UNDERSTANDING FOR EMPLOYMENT LINKED SKILLING PROGRAM (ELSP)

This Memorandum of Understanding (hereinafter referred to as "MoU") is made for providing employability training and placement assistance through Employability Linked Skilling Program (hereinafter referred to as ELSP) and executed on this 6th day of August 2018 at Palghar by and between:

Sonopant Dandekar Shikshan Mandal's Sonopant Dandekar Arts, V.S. Apte Commerce and M.H. Mehta Science College, Palghar represented by its President Adv. G. D. Tiwari and having its campus at Kharekuran Road, Palghar (W), Tal. & Dist. Palghar, Maharashtra-401404 (hereinafter referred to as the Institute)

Schoolguru Eduserve Private Limited, represented by its Vice President Mr. Uditendu Bose, incorporated under the provisions of Companies Act, 1956, having its registered office at 903, Western Edge II, Western Express Highway, Borivali (E), Mumbai – 400066, (hereinafter referred to as Schoolguru)

BACKGROUND

1. India is facing an interesting dilemma of educated but unemployable youth sub-population which is getting larger by the day. There are jobs which are emerging in sunrise industries. However, many such jobs are going abegging as the requisite skills and experience is not observed in candidates being presented for interview. Schoolguru along with the Institute on one hand and its Industry Partners on other hand, intends to intervene and positively influence this concern.
2. Whereas the Institute is a premier state open Institute, providing high quality education to its students and is making efforts to offer placement assistance to its students.
3. In this connection Schoolguru has submitted a formal proposal and subsequently made a presentation to the Institute officials. This program is called Employment Linked Skilling Program (hereafter referred as ELSP).
4. Following the presentation the Institute officials have found the proposal suitable to help the students with employability skills training along with placement assistance.
5. The ELSP Program is designed with the objective of getting the participants job ready by providing them the skilling needs of prospective employers. The course has been developed with an emphasis on lending practical knowledge alongside theoretical explanations, thus remarkably improving the participants' employability skills.

To achieve the common goal, the Institute and Schoolguru have decided to collaborate on a non-exclusive basis on the following framework to provide finishing skills and placement assistance to all the students of the Institute.

ROLE OF THE INSTITUTE

1. the Institute will propagate ELSP among current as well as passed out students to make them aware about the availability of ELSP
2. the Institute will use SMSes, e-mailers, Institute prospectus and other mediums to create awareness about ELSP
3. the Institute will provide a link to ELSP program through their website www.teamleaseuniversity.ac.in/ to enable the students to register for ELSP
4. the Institute will allow the students to undergo ELSP along with their degree/diploma program
5. The Institute shall permit Schoolguru to set up a helpdesk for ELSP in the Institute for the benefit of the students and run promotional campaigns
6. The Institute agrees to co-certify the program and lends its name on the program completion certificate for the students

ROLE OF SCHOOLGURU

1. Schoolguru will provide the online platform for students to self-enrol in the ELSP program. The link for student to use the online platform will be made available on the Institute website www.teamleaseuniversity.ac.in/ Schoolguru will design the training and placement process and manage the technology platform, content upgradation to ensure smooth functioning of ELSP program.
2. Schoolguru will make the ELSP content available to students through a website, mobile app etc and make provisions to download the app from play store.



3. Schoolguru, in association with its industry partners shall arrange field/practical work opportunities for Institute students who will complete the theory portion and assessment successfully.
4. On successful completion of both basic & advanced modules, followed by successful completion of required field/practical work, Schoolguru, in association with its industry partners shall arrange placement opportunities for students.
5. Schoolguru will charge a registration fee from students which is fixed as Rs.100/- + tax per student.
6. Schoolguru shall charge the full course fee of Rs 7000/- only from those students who secure either a paid apprenticeship or a job opportunity through Schoolguru and its partner TeamLease.

PROGRAM ELIGIBILITY

1. This ELSP program would target to invite the Institute students who are 10+2 or undergraduates and are keen to enter the "Corporate sector".
2. Initially the industry tie-ups will focus on preparing participants for jobs in BFSI, Logistics, Manufacturing, e-Commerce and Retail sector. More industry sectors shall be added as more tie-ups are secured.

PROGRAM DURATION

1. Total duration of ELSP is 3 months which includes training on 6 modules.
2. The students who successfully complete the program shall be expected to undertake on the job paid training (apprenticeships) that can range from 3 – 36 months

INTELLECTUAL PROPERTY

Both the Institute and Schoolguru will hold rights to their respective intellectual property. Schoolguru will be the sole owner of any content that it develops including Video content for the programs covered under this MOU.

TERM OF MOU

This MOU is for a period of one year from the date of signing this letter of MoU. Parties shall jointly and annually review the terms of collaboration including the training requirements, delivery roles and pricing.

OTHER TERMS AND CONDITIONS

1. The parties are responsible for their individual acts of commission and /or omission, due to their negligence with respect to financial risks, compliance of statutory liabilities and obligations, and render services in accordance with the terms and conditions agreed herein.
2. The parties shall perform their obligations towards each other in such a manner herein committed as would prevent acts of commission and/or omission resulting in breach of the terms and conditions and loss to each other.
3. The arrangement is on a principal to principal basis and no party shall hold each other as agent and or principal of the other for any liability.
4. This MoU is not intended nor shall be construed as creating a joint venture, partnership or other form of business association.
5. In no event shall the Institute or Schoolguru be liable for any incidental, punitive, direct, indirect or consequential damages whatsoever, (including but not limited to damages for loss of profits or confidential or other information, for any kind of interruption, for personal injury, for loss of privacy, for failure to meet any duty including of good faith or of reasonable care, negligence, and any other pecuniary or other loss whatsoever) or otherwise in the event of fault, tort (including negligence), misrepresentation, strict or product liability, breach of

contract or breach of warranty and even if the party has been advised of the possibility of such damages.

TERMINATION

1. This MOU being for a specific period shall come to an end upon expiry of the date of validity of this MOU. The MOU may be extended for a further period of 5 years on mutual consent. This MOU may be terminated for convenience and without cause before the expiry of the validity period by each party by giving 60 days' notice.
2. The parties shall be entitled to terminate this MOU with at least 60 days prior written notice, if it discovers that the other has committed acts of commission or omission which is prejudicial to the interests of party terminating the contract and has concealed information required by the party to check the compliance of the terms and conditions of this MOU.
3. All rights and entitlements of the parties relating to IPR, trademarks, copy rights, and confidentiality of business process, methods and documents shall survive without limitation, expiry, determination or termination.

CONFIDENTIALITY OF INFORMATION


The parties shall severally take care to ensure that the information provided by the other party remains confidential and further agree not to use the Confidential Information for any purpose other than the purpose for which it is intended. The parties shall not disclose any Confidential Information to anyone other than the employees of either organization who need to know the Confidential Information. This clause shall survive this MoU.

TRADE MARKS, TRADE NAMES AND IPR'S

1. The parties hereby acknowledge and confirm that all intellectual property rights in respect of and relating to the trademarks, service-marks, copyrights, trade names including their respective corporate names, brand name or any part thereof (hereinafter collectively referred to as "Intellectual Property") are owned / possessed by respective owners and nothing contained in this MoU shall, unless specifically provided, be deemed to authorize the other party to use or give any right in respect of any of the Intellectual Property of the respective owners.
2. The parties shall not use in any manner whatsoever, any of the Intellectual Property, registered or not except as expressly authorized writing and restricted to the purpose/ period thereof.
3. The parties shall strictly comply with requirements and specifications relating to the display of any logo, trademark, and copyright relating to the Intellectual Property.
4. Upon the expiry or termination of this MoU for any reason, the parties shall immediately cease and desist for all time from any use of or reference to the Intellectual Property of the other party.
5. The parties acknowledge and confirm that all materials given by them whether in printed, written or electronic form, constitute copyright ownership of respective parties and reproduction in any form or by any means mechanical or electronic including photocopying, recording or by any information storage or retrieval system is not permitted and shall constitute a breach of the terms of this MoU warranting such steps as may be deemed appropriate including but not limited to termination of this MoU.

DISPUTE JURISDICTION AND RESOLUTION

1. Any and all differences and disputes whatsoever arising between the parties shall in the first instance be resolved mutually between the parties and in the



event of a non-resolution the matter may be referred to arbitration to a person jointly appointed by the parties as per the law relating to arbitration in India and the decision of the arbitrator shall be final and binding on all parties. The arbitration proceedings shall be held in Chennai.

2. All disputes shall be governed in accordance with the laws prevailing in Chennai. Only competent courts within Chennai shall have jurisdiction to try any suit or proceedings whatsoever arising or in any way connected with this MoU.

ASSIGNMENT


Neither party shall, without the other's prior written consent assign, change, charge or otherwise transfer or delegate or share the rights, obligations or any provision of this MoU to any other person.


