CLAUSE 1

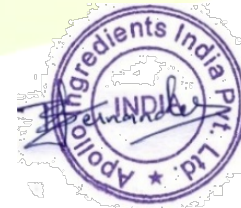

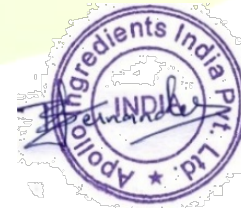
