

# Bachelor of Vocation Degree in Pharmaceutical Chemistry HUB REGISTRATION- MOU AGREEMENT OF LEASE

This Agreement of Lease made on 04<sup>th</sup> May 2018 between President, Sonopant Dandekar Shikshan Mandali, Kharekuran Road, Palghar - 401404 hereinafter called the 'GRANTER'

### AND

M/s CEO Skill Foundations Private Limited, Plot No. 19, Singaravellan Nagar1<sup>st</sup> Street, Near Maduravoyal Market Stop, Maduravoyal, Chennai- 600095 hereinafter called the GRANTEE.





**Whereas** vide agreement of understanding dated 30<sup>th</sup> day of December 2013 between TATA INSTITUTE OF SOCIAL SCIENCES-SCHOOL OF VOCATIONAL EDUCATION (TISS-SVE) AND CEO SKILL FOUNDATION PRIVATE LIMITED had made a tie up to give vocational vertical/skill in pharmaceutical courses through CEO SKILL FOUNDATION PRIVATE LIMITED in various institution as Hub partner (learning center) and after completion of three years. The degree of BACHELOR OF VOCATIONAL EDUCATION will be conferred to the students by TATA INSTITUTE OF SOCIAL SCIENCES.

Further whereas by MASTER SKP AGREEMENT for conduct of B.VOC program (agreement) dated 3<sup>rd</sup> day of October 2017 between TATA INSTITUTE OF SOCIAL SCIENCES-SCHOOL OF VOCATIONAL EDUCATION (TISS-SVE) and LUPIN LIMITED it was decided that they will create a Hub partner (learning center) and SKP to enable it to reach out to the millions of youth across the country. The parties hereby agreed as per above understanding this agreement between the parties here to witnessed as follows.

The Grantee is known to the Granter and in the premises of the Granter described in the Schedule of the Agreement of Lease. The Granter herby grants the Grantee permission to run "Bachelor of Vocational Education in Pharmaceutical Manufacturing Technology" for 3 years course in 06 semester at Class Room, Conference Hall (PPT Presentation purpose only), Computer Lab, situated at **Sonopant Dandekar College, Palghar** in the scheduled premises as under:

#### This agreement therefore witnesses as follows

- 1. That the Granter allows the Grantee to run Bachelor of Vocational Education in Pharmaceutical Manufacturing Technology" for 3 years course in 06 semester in the scheduled premises (Only Computer Lab shall be utilized per semester for 5 to 7 Sundays) as described in the Schedule, for a period beginning from **O1st JULY 2018 to 30th JUNE 2021.**
- 2. That the Grantee shall have no right to claim as a tenant of the Granter and shall only be considered as a grant to occupy the premises for the aforementioned period only till further extended.
- 3. That the occupancy grant amount shall be **Rs.10,000/**-( Rupees Ten Thousand) only, as lumpsum and the same shall be paid within the tenth day of every following month.

- 4. That the Grantee agrees to keep and maintain the premises clean, proper and in decent condition and shall not suffer the premises to be in a bad state of repair, and out-look during the currency of this agreement and shall not in any manner damage the walls, floor or any other structure within the premises nor cause any kind of obstruction in and around the premises in any manner whatsoever.
- 5. The Grantee agrees not to be entitled to allow any other person to occupy the premises for any purpose during the period of lease or to use any part thereof without consent in writing of the Granter.
- 6. The Grantee shall not make any addition or alteration etc. in the premises without the written permission of the Granter.
- 7. Any extra electrical/ water connections etc., if required shall do by the Grantee, but only after obtaining written permission from the Granter. Expenses for such connections, additions, alterations etc. whatsoever shall be borne by the Grantee.
- 8. That during the period of occupancy, the Grantee wishes to vacate the allotted premises, a notice of one month in advance shall be tendered and vise-versa.
- 9. In case of any disputes arising between the parties herewith interpretation, conduct or performance of any of the terms and conditions of this Agreement, the same shall be referred to **President**, **Sonopant Dandekar Shikshan Mandali**, **Palghar** whose decision thereof shall be final and conclusive and not open to challenge or review.
- 10. In witness whereof, the parties of this agreement have signed this deed on the day first above-mentioned. A true copy thereof signed by both the parties has been delivered to the parties retaining original with the greater.
- 11. In the event of failure by the Grantee to abide by the terms and conditions contained in this Agreement, the Granter may terminate the Agreement and Grantee shall vacate the premises within 60 (Sixty) days of notice issued on this regard.
