- So, based on the strengths of the entities and proven record, it is proposed to set-up joint program under the name "MSME Desk" by WX Consultants Private Limited and Sonopant Dandekar Arts, V.S. Apte Commerce and M. H. Mehta Science College, Palghar.

Now therefore, in consideration of the promise to set-up successful "MSME Desk" as per the details in Annexure I,

THE PARTIES HERE TO AGREE AS FOLLOWS:

1. CLAUSE 1: AREA and SCOPE OF COLLABORATION:

- 1.1. The aim of this MOU is primarily to establish terms of collaboration and co-operation, under which both the parties seeking the MOU, shall perform collaborative efforts for successfully establishing and operating "MSME Desk" in a self-sustainable mode.
- 1.2. In "MSME Desk" structure, the terms of association based on revenue sharing model, scope of activities, benefits for the participating members as per the process of operation shall exclusively follow the guidelines mentioned in Annexure-I.

2. CLAUSE 2: CO-OPERATION

- 2.1. First party shall assign coordinator who can ensure co-ordination & preparation of six month progress report jointly with person designated by from Second party. Also, on pre-booking basis the conference room & meeting room, Technical labs, Machineries and other infrastructure support shall be made available as & when required to co-ordinate with institutes, mentors & / or industries under the "MSME Desk". The effectiveness will be measured by actual milestones achieved against the set milestone.
- 2.2. As far as the minimum set milestones are achieved as per the targets mentioned in Annexure-I, through collaboration of both the parties, the "MSME Desk" shall keep running exclusively between parties and no third-party engagement shall be entertained.
- 2.3. Addition or removal of any terms of association from annexure I, shall be done through written consent of both parties for the betterment of the program outcome.
- 2.4. Any new activity other than mentioned in Annexure-I, shall be discussed separately and its scope and framework will get defined through mutually agreeable terms of association before its execution.

3. CLAUSE 3: INTELLECTUAL PROPERTY PROTECTION

3.1. Nothing contained in this MOU shall, by express grant, implication, Estoppel (the principle which precludes a person from asserting something contrary to what is implied by a previous action or statement of that person or by a previous pertinent judicial determination) or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

4. CLAUSE 4: IMPLEMENTATION METHODOLOGY

- 4.1. Review committee should be formed consisting of two senior members from each party to set the targets and milestones. Same committee shall take review of the activities, terms of reference and achievements against set milestones and submit the report semiannually to the WX Consultants Private Limited for recommendation of improvement and betterment of the program.
- 4.2. The recommendation for modification shall be judged judiciously maintaining the interests of the entities intact and with due considerations to its financial viability and impact.
- 4.3. The second party has to nominate two Members form from Office bearer team MSME Desk.

5. CLAUSE 5: LOGO USAGE

- 5.1. At all functions / literature related to this MOU activities, Sonopant Dandekar Arts, V.S. Apte Commerce and M. H. Mehta Science College, Palghar logo shall be use as an Academic Partner whereas WX Consultants Private Limited logo shall be consider as an Incubation Partner of the program.
- 5.2. At all promotional material of both parties, the Sonopant Dandekar Arts, V.S. Apte Commerce and M. H. Mehta Science College, Palghar logo shall be used as an **Academic Partner** whereas WX Consultants Private Limited logo shall be consider as an **Incubation Partner**.

6. CLAUSE 6: VALIDITY and TERMINATION

- 6.1. This MOU is valid from 1st December 2021,This Mou is valid for Three years, both parties agreed that the right to terminate the contract is exercised by any one of us prior notice to the other party.
- 6.2. Program framework of operation are mentioned in Annexure-I. It shall get reviewed and updated through mutual agreement every year by the review committee at the time of annual review.

- 6.3. Both parties shall discuss mutually and its scope and framework of "MSME Desk" on agreeable terms of association.
- 6.4. Either party can terminate the agreement by giving notice of 30 days. Each party shall fulfill all committed financial, non-financial and operational obligation and activities (As per all keys mentioned in Annexure-I) before completely closing the terms of association of this MOU.

7. CLAUSE 7: COMMERCIALS

Any services mentioned in list of services offered by WisdomXtra shall be discussed commercially with its scope and framework. It will get defined through mutually agreeable terms of association before its execution.

8. CLAUSE 8: RELATIONSHIP BETWEEN THE PARTIES and GOVERNING

- 8.1. It is expressly agreed that First Party and Second Party are acting under this MOU as independent entities, and the relationship established under this MOU shall be specifically for the "MSME Desk" as per the scope mentioned under annexure-I. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.
- 8.2. As professional practice, neither Party is not expected to directly engage, assign work, or recruit other party nominated persons (nominated for conducting any of various Activities under this MOU).
- 8.3. Governing laws and arbitration: The MOU shall be construed Page 11 of 14

and governed by the laws of India. Any controversy or claim arising out of or divergence or difference derived from the interpretation or application of the MOU or breach thereof shall be resolved/settled by arbitration , to be held in Nashik as in accordance with the rules of the arbitration and conciliation Act 1996

9. CLAUSE 9: TERM OF AGREEMENT

This Agreement shall be effective from the date of execution of this Agreement for conducting Programs from 1st December 2021 to 30th November 2024.


