BACKGROUND:

The Sonopant Dandekar Shikshan Mandali came into existence in August 1968 to commemorate the late principal Sonopant Dandekar.

The saintly personality late principal Sonopant Dandekar whose blessings are always with this institution, this institution has been developing in view of the educational requirements of this locality. In building up this institution, the inhabitants, social well wishers, and education loving people in this surrounding locality have always extended their hands of help and co-operation.

The college campus extends over nearly 21 acres. The college functions in its own buildings which are situated on Kharekuran road at distance of 2 k.m. from Palghar railway station (W.R.). R. H. Save Arts, C. J. Bhanushali Commerce and B. A. Dandekar Science Junior College Palghar is being conducted by this institution. Moreover as per government educational policy following three courses are started at +2 level based on minimum competency skills.

1. Electronic Technology
2. Accounting and Auditing
3. Horticulture

MEDIUM OF INSTRUCTION:

The medium of instruction shall be English for Science and Commerce streams and for Arts stream the medium of instruction shall be Marathi. However college management intends to introduce English medium for Std. XIth Arts class from the ensuring academic year if sufficient number of students desire to offer the English medium.

RULES OF ADMISSION:

A. Admission to first year of Arts and Commerce class

The students who have passed SSC Examination (with English Subject) of Maharashtra State Board of Secondary and Higher Secondary Education are eligible for admission to first year of the junior college. Those students are not required to submit the 'Eligibility Certificate'.

B. Admission to first year of Science class

The students who have obtained minimum 40% of marks in the Science subjects are eligible for admission to first year of Science class. The students who have passed SSC Examination of Maharashtra State Board of Secondary and Higher Secondary Education are eligible for admission to first year of the junior college. Those students are not required to submit the 'Eligibility Certificate'.

C. Eligibility Certificate for Admission

As per the Rule No. 80(1) of Maharashtra State Board of Secondary and Higher Secondary Board of Education Regulation 1977, the students who have passed S.S.C. or equivalent examination from other examination boards of other states except Maharashtra State, Central Boards of Secondary Education, and Examination Boards from other countries at secondary or equivalent Examinations are required to obtain '**Eligibility Certificates**' for seeking admission at 11th and 12th classes.

From educational year 1997-98 the change in boards' traditional system of obtaining Eligibility Certificate has been introduced and the students seeking admission here from outside the state of Maharashtra or from Examination Boards of other countries will be granted provisional admission according to equivalency list after scrutiny of their documents and thereafter these cases will be sent to the M. S.,B. of S. & H.S. Education, Mumbai for obtaining Eligibility Certificate.

While granting admission to above type students, the following documents are required:

1. a) Board's prescribed form of Eligibility Certificate.
b) Statement of marks
c) School leaving certificate (Counter Signed by Concern District Education Officer)
d) Passing certificate.
e) Original migration certificate.
f) Schedule 'A' (for foreign Students as per page no. 4 of eligibility form)
g) Syllabus of subjects passed.
h) Deed of undertaking. (Format given by HSC Board)
i) Aadhaar Card
2. The Junior College is required to acquire the deed of undertaking on stamp paper of Rs. 100 from the concerned students before granting them admission.
3. If the Students seeking admission under eligibility certificate is unable to submit all the documents along with an application of obtaining eligibility certificate, then in these cases, on the submission of school leaving certificate, statement of marks and deed of undertaking, the concerned students may be granted provisional admission. However, the concerned student is required to submit the remaining documents for obtaining the eligibility certificate.
4. Fees to be collected from the students for obtaining eligibility certificate as prescribed by the board.
 - Per student Rs. 100/- for coming from outside Maharashtra state.
 - Per student Rs. 500/- for coming from foreign countries.
5. The Junior college is required to submit all the received applications for eligibility certificates up to 15th September to the Board by hand delivery with Rs. 400 per student.
6. The last date of fulfilling the remaining documents by the students applied for obtaining of Eligibility Certificate (Standard 11th) will be 20th January.
7. Late fee Rs. 10/- per day / per case will be collected after 20th January from the students of standard 11th & 12th who are unable to fulfill the requirement of submission of documents.
8. The students are liable for cancellation of admission if they are unable to produce Eligibility Certificate.
9. The 11th Std. Annual Examination result will not be declared of the students if they are unable to produce all the documents and obtain Eligibility Certificate. The students seeking admission on the basis of Eligibility Certificate will not be confirmed without Eligibility Certificates.
10. As per Board Regulation No. 79 (1), the student seeking admission in Stds. 11th & 12th are required to pass in five subjects along with English. The minimum marks required to pass must be in all subject.
Format of equivalency list and deed of undertaking is available in the office.

D. For Backward Class Students Only (SC/ST/NT/SBC & OBC)

Documents required for Govt. of India scholarship & freeship:

1. Caste certificate issued by Tahsildar.
2. School leaving certificate.
3. First & last page xerox of ration card.
4. Income certificate issued by competent authority if father is in Govt. Service. The income certificate should include basic pay, DA, HRA & other allowances. The income certificate showing only basic pay will not be taken into consideration.
5. Income certificate issued by Tahsildar if father is businessman or farmer.
6. Mother's income certificate if father is not alive & certificate by Grampanchayat or Nagar Parishad regarding father being not alive.
7. Husband's income certificate if applicant female student is married.
8. Last year examination marks statement.
9. Gap Affidavit on stamp paper of Rs. 100/- if student has left college last year or there before.
10. The district change certificate from concerned social welfare officer if student is resident of other than Thane District, mentioning whether student has received or not received scholarship from concerned social welfare officer.
11. Non creamy layer certificate is required for NT/SBC/OBC & Govt. of India scholarship and free ship.
12. Xerox copy of the fee receipt received at the time of seeking admission.

The applications must be submitted in office as per given notice along with necessary documents and Aadhar Card.

PHYSICALLY HANDICAPPED SCHOLARSHIP SCHEME

The Students can avail the Handicapped Scholarship Scheme who can complete two terms as per Rules.

Documents Required for Physically Handicapped Scholarship.

1. Application in the prescribed form.
2. School leaving certificate.
3. Certificate by competent authority of being Physically Handicapped.
4. Income certificate by Tahsildar.
5. Last year's marksheet
6. The fee receipt received at the time of seeking admission.
7. Photograph.

RAJARSHI CHHATRAPATI SHAHU MAHARAJ MERIT SCHOLARSHIP SCHEME (SC/NT/SBC Students)

The above category students who obtain 75% marks or above in SSC Examination are eligible for obtaining above scholarship. The students may have sought admission in XI Standard of Jr. College and should have successfully completed an educational year. Those students should apply in the office as per given schedule regarding to same.

Documents Required for this Scholarship:

1. Caste Certificate;
2. SSC Examination Marksheet;
3. Bonafied Certificate of Junior College;
4. Income Certificate.

RAJARSHI CHHATRAPATI SHAHU MAHARAJ MERIT PRIZE SCHEME (For SC/NT/SBC Students)

This scheme has been implemented for encouraging the above category students to obtain highest marks in HSC Examination among general Students.

SCHOLARSHIP FOR BC CATEGORY BOYS / GIRLS STUDENTS FOR EDUCATION IN FOREIGN COUNTRIES.

1. The student, obtaining 60% Marks in the HSC Examination and 55% Marks in the Degree Examination at the first attempt is eligible for this scholarship.
2. The annual income limit of students' parents should be up to Rs. 2.50 lacs.
3. The student should have sought admission in foreign University.
4. Age of the student should up to 35 years.
5. Applications must be forwarded in the prescribed format.

Following documents are required to attach with an application

1. Original school leaving certificate & its two attested xerox copies
2. 10th / 11th examination passing marks statements & two attested xerox copies.
3. Two attested xerox copies of passing certificate.
4. Recent four passport size photographs.
5. Caste Certificate (B.C. students) two attested xerox copies.
6. NCC / Scout Certificate if available (+2 Level) vocational courses.
7. State level participation certificate in athletics and sports, if available.
8. Intermediate drawing examination passing certificate, if available.

E. ATTENDANCE IN CLASSES.

The Students studying in Junior College are required to maintain minimum 75% attendance of the working days including practical in each term. Otherwise, their terms will not be granted and consequently, they will be disqualified for appearing the examination and liable for cancellation of admission.

Under some exceptional circumstances, the competent authority may condone deficiency in attendance, a student must apply with necessary documents if his attendance is less than 75% but more than 60%

Those Students who are confident of fulfilling condition of 75% attendance should seek admission during the educational year 2022-2023. Those students who are not confident of fulfilling the above condition should not seek admission in junior college.

The Students of Std. 11th & 12th classes are required to prepare project report and that subjects' Grades will be included HSC Examination Board Result.

Rules regarding being eligible for admission in second year (12th) of Junior College.

The Student are eligible for admission in second year of Junior College on the basis of marks obtained in tutorials, unit test, 1st term end, 2nd term end examinations of 11th classes as per rules of the board.

Similarly, minimum 'C' grade is required to obtain by the student in the unit tests during the year as per revised syllabus of 'Physical Education'.

If the students could not appear for an examination due to illness, on medical ground those students are given an opportunity to reappear the examination.

Parents are requested to be very careful about the academic progress of their wards, this will be in the interest of their wards and this will be beneficial for future career of their wards. The parents are further requested to co-operate the junior college in enriching the academic interests of their wards.

Students are required to obtain average 35% marks in all subjects for passing. Moreover, for securing admission in second year, students are required to pass in all subjects.

BI-FOCAL COURSES (COMPUTER SCIENCE, BANKING):

College has been started Bi Focul Course in Unaided Science stream viz Computer Science since educational year 2015-16 and Banking from 2021-22.

BENIFITS OF BI-FOCAL COURSES (COMPUTER SCIENCE ATTACHED WITH SCIENCE STREAM):

This course provides a platform for the students who wish to go for professional degrees like B.Sc. (Computer), B.Sc. (I.T.). It gives rebate of two general subjects to students who are inclined and determined to go for professional / conventional education in future.

This subject is practical oriented and hence enables the students to obtain high scores and thus better over all result & higher percentage in th HSC Mark Sheet.

BIFOCAL BANKING COURSE (ATTACHED WITH COMMERCE STREAM):

The college is planning to start Bifocal Banking Subject from academic year 2021-22. This subject gives basic and practical knowledge about banking which is used for carrier in banking as well as cometicitive exams and business.

ENGLISH MEDIUM ARTS:

Arts is the most versatile stream. Student can opt during their higher secondary level studies which will prove very helpful for preparations of various competitive and civil services examinations.

POSSESSION OF UNFAIR MEANS IN EXAMINATIONS:

Disciplinary action will be initiated against students as per rules, regulations and guidelines related to examinations, if a student is found indulging in unfair means practices during the examinations. If student is found guilty, his admission is liable for cancellation. In this respect, the decision of principal is final. The students are instructed to see the notice board regularly. The parents are instructed to take due care that their wards will not involve in unfair means during examinations.

GROUP INSURANCE FOR STUDENTS:

So far as to provide security to the students, the college has introduced since 2002-2003, Group Insurance Scheme for the students. Students will have to pay nominal premium for the same.

NATIONAL SERVICE SCHEME:

Junior college intends to start National Service Scheme Branch, if sufficient number of students are available, the students should contact Vice Principal after admission.

NATIONAL CADET CORPS:

NCC has been functioning from June 1971 in this college for boys & girls and forms a characteristic feature of college activities. Some students of Junior College are granted admission in this unit as per their merit along with senior college students. The desirous students are instructed to contact NCC chief major B. K. Sakhare & Lt. Anagha Deshmukh immediately after admission.

RULES REGARDING PAYMENT OF FEES:

1. The other students except the BC students will have to pay the whole year's fee at the time of admission.
2. The prescribed fees from backward class students will not be accepted at the time of admission who are eligible and who wish to avail Govt. of India backward class scholarship. However, they will have to pay the prescribed amount of deposit at the time of confirming the admission.
3. The students other than included in above 2 will have to pay yearly full fees including the tuition fees at the time of admission. Similarly, concerned educational fee concession applications along with necessary documents will have to submit within one month or within 31st July whichever is earlier. After the amount of fees is made available from the competent authority to the Junior College, the fees will be refunded to the students by the Junior College by displaying notice at the prominent place by the Junior College.
4. Any student including backward class students, if fails to submit fee concession forms along with necessary documents within the stipulated time, and if the competent authority rejects the applications, then in such cases, the student will not avail any type of fee concession. Consequently the student will not be refunded the fees already paid by him. Similarly, the same fees will be collected from the students in case fees have not been paid by the students. The prescribed various educational fee concession forms are made available in the office on demand.

RULES OF RECEIVING OF FEE PAID IN CASE OF ADMISSION CANCELLED:

1. Before the commencement of educational term, if under any reason if particular student applies in writing to the principal regarding cancellation of his admission, the student will be refunded tuition fee, examination fee and library deposit, but admission fee will not be refunded.
2. If student desires to cancel his admission after the commencement of the educational term, the student is required to submit an application accordingly to the principal. The student will not be refunded admission fee & term fee. Deposit will be fully refunded. However, the remaining fees will be refunded by charging the tuition fee up to the month during that term.
3. Student will have to submit an application before the completion of the educational year to receive an amount of fees.
4. The student applied for fee concession, if he cancels admission before the completion of the educational year, he will have to pay full fees of the Junior college.

S.T. / RAILWAY PASS CONCESSION:

The student will be made available the above pass concession for journey from resident to college and back. For that, prescribed request application will have to submit. The prescribed format will be made available in S.T. office. After the expiry of the S.T. concession pass, the further concession form will be made available on the basis of the previous pass after contacting the S.T. office. No fresh application is required for that. Railway journey pass concession is made available to go to their place of birth and to come back as per mentioned in their admission form during vacation.

VERIFICATION OF CASTE VALIDITY CERTIFICATE OF BACK WARD CLASS STUDENTS:

The Students, studying in Std. 11th and 12th science classes during the academic year 2021-22, if

they wish to seek admission to D.Ed., Medical, Engineering and equivalent courses are required to obtain caste validity certificates. An application in prescribed format is required to be submitted. The desiring students should contact college office as per given notices.

USE OF SMART / INTERACTIVE BOARDS IN TEACHING - LEARNING PROCESS:

College is providing educational smart / interactive boards for betterment of teaching - learning process.

Use of smart board / e-board will allow teachers and students to learn collaboratively, share files, access online resources and use of educational software.

LIBRARY:

The reference books, supplementary books, the books recommended by study boards and the textbooks of the subjects Marathi, English & Hindi are made available in the library. Moreover, various magazines, dailies, studies pamphlets are made available to the readers in the library. As on books amounting to Rs. 1 Lacs, have been purchased in the library and addition has been made in it from time to time. The library is well equipped with by adding books amounting to Rs. 5 Lacs, with the assistance of the University Grant Commission.

LIBRARY RULES:

1. In the beginning of every academic year a Reader's Ticket is issued to the students for borrowing books from the library. Only one book except reference books can be taken against this ticket for home reading for a period of 1 week.
2. The book issued for home reading must be returned on or before the date stamped by the library. Rs. 1/- per day fine will be charged for the student for late submission of books in the library.
3. The Student can have one or more books against his identity cards in the library reading room. Such books can not be taken out of the library. If taken out of library Rs. 2/- per day fine will be charged from the student.
4. A student can also have reference books, dictionaries, encyclopedias, atlases etc. for his study in library reading hall. He/She can not take such books out of the library.
5. A student should not cause any disturbances to his co-students present in the library.
6. Student must return the books immediately after the examination is over.

PARENT TEACHER ASSOCIATION

Parent teacher association is established as per the circular number S.S.N.2696/(622)/96 S.E.3 of Maharashtra Govt. Primary education department dated 18/10/1997. Each ward's parents will be a member of this association.

The main intention of this association is to solve the academic problems of students and teachers, they are not expected to look after in the daily routine working of the junior college and administration or to interfere their in. This has been declared in govt. rules in this respect. The details about this will be made available in the office during office hours. The parents of the students are expected to remain in contact of the junior college. They are expected to keep vigil towards their wards' attendance, progress and conducts. They should see their examination results and attend the meetings. There will be no compromise on matter of discipline of the wards.

CODE OF CONDUCT IN THE JUNIOR COLLEGE:

1. Every student after admission must always carry identity card with his photograph affixed thereon and signed by the principal.
2. Every student is required to wear prescribed uniform. Student will be liable for disciplinary action if he/she disobeys this rule.

3. Students must attend lectures, tutorials, practical or unit test according to the time table on all working days of the junior college. In case of absence prior permission of the principal is required otherwise their terms will not be granted. Student must note that if their attendance at lectures, tutorials is found unsatisfactory their terms will not be granted and will not be allowed to appear to annual examination. Resultantly they will lose the year.
4. In case of illness, students must apply for leave in writing as early as possible with doctor's certificate attached to the applications and must report to the principal immediately after resuming. Such leave will be granted according to rules and regulations in respect of minimum attendance.
5. Conduct and behavior of the student in class or in the premises in the college must be such that will not cause disturbance to fellow students or to other classes.
6. Students must not loiter in the college verandah while the classes are engaged.
7. Mobiles phone & camera are strictly prohibited in the college campus.
8. Smoking, gutkha & tobacco chewing is strictly prohibited in college campus.
9. In case of any difficulties or complaints in connection of junior college matters, the students may frankly see personally and write to the Principal, Vice principal or Supervisor. Except them they may not see and write to any officers. Similarly, they shall not write to the press any thing without prior permission of the Principal.
10. No society or association shall be formed in the college and no meeting can be organized or addressed without prior permission of the Principal.
11. Students shall not collect any money as a contribution for picnic, trip, get together, study notes, charity or any other activities without prior permission of the principal.
12. Students of the college should take care to maintain college property and campus in a good order. They are liable for punishment if they damage the college building and campus, e.g. writing on walls, damage to the college property, disconnecting the electricity etc.
13. Students, wishing to obtain signature of the principal on any type of document should first approach to the head of the office. They should not directly approach the principal for obtaining signature on paper.
- 14. Student of the college must observe all rules and regulations of the college. Student whose behavior is found to be rude and unworthy in any way is liable to be removed from the college or will be punished accordingly. The principal's decision in such matters shall be final.**
15. Matters not covered by the existing rules will rest at the absolute discretion of the principal.
16. The cloth for uniform of the junior college will be made available at reasonable price through Student Consumer Co-operative Store. The student should purchase the cloth through Student Consumer Co-operative Store only.
17. A. **The students who fail to seek admission during the stipulated period once their names are declared in admission list shall loose their claim for admission for XIth class. The students should carefully see the admission lists and confirm their admissions accordingly. No excuse will be entertained for giving admission of such students / parents.**

The students should keep ready with them the Copies of Passport size photograph, Statement of Marks & School Leaving Certificate.
